### **CITY ENGINEER'S REPORT**

Jack Sykes with Summit Engineering provided the Commission with a status report on the Thompson Road Right-Of-Way Acquisition. Parcels 3, 2, 4, 5 and 18 are now turned over to the City Attorney to proceed with condemnation. The report had a more detail description of the parcels. Mr. Sykes also reported the Contractor met regarding the Lee Avenue Extension. This project will be short.

City Attorney, Russell Davis asked the Commission to consider a request to adopt a resolution for authorization of condemnation of property for Thompson Road Development located on Thompson Road. Commissioner Carter made motion to approve. Commissioner Layne seconded the motion. Motion carried unanimously.

#### AGENDA ITEM E. POLICE DEPARTMENT UPDATE

Police Chief Adkins updated the Commission no the recent hiring of Addison Baisden. He started work with the City of Pikeville today. WalMart also requested for the police department to assist with the Christmas in July event the Shriner's are hosting as a fundraiser. Officer Conn, our D.A.R.E. Officer will be attending the event. Chief Adkins also updated the Commission on the "No Parking" signs that have been posted on the Bypass Road sidewalks. They are apparently working because the ticket writing has been reduced during the EKEC events.

- 4. Consider request to cancel the April 14<sup>th</sup>, 2008 Regular City Commission Meeting due to Hillbilly Days week. Commissioner Davis made the motion to approve. Commissioner Layne seconded the motion. Motion carried unanimously.
- 5. Consider request to renew contract with YMCA for operation of the City Pool and authorize the Mayor to sign contract on city's behalf. Commissioner Chaney made the motion to approve. Commissioner Layne seconded motion. Motion carried unanimously.
- 6. Consider discussion for request to add driving range property to YMCA's existing lease for the development of an events field for their youth programs. Commissioner Chaney made motion to approve. Commissioner Layne seconded motion. Motion carried unanimously.
- 7. Consider request to hire Shawn Amos to the position of Main Street/Events Clerk at starting rate contingent upon passing of all required pre-employment tests. Commissioner Layne made the motion to approve. Commissioner Davis seconded motion. Motion carried unanimously.

Donovan also requested to post the position of Police Officer to replace resigning officer Chris Nickels. Commissioner Layne made motion to approve. Commissioner Chaney seconded motion. Motion carried unanimously.

Donovan also requested to accept the overlook fencing bid submitted by Ray's Fencing, LLC. Commissioner Chaney made motion to approve. Commissioner Carter seconded the motion. Motion carried unanimously.

8. Consider request for a closed session for purpose of discussing Economic Development, personnel and legal issues. Commissioner Davis made motion to approve. Commissioner Chaney seconded the motion. Motion carried unanimously.

Commissioner Carter made motion to re-convene into regular session. Commissioner Chaney seconded the motion.

Donovan requested to receive bids for two aerating fountains for the Pikeville Pond. Commissioner Chaney made motion to approve. Commissioner Carter seconded the motion. Motion carried unanimously.

Donovan also presented a first reading of an ordinance regarding Car Washes.

Donovan reminded the Commission on the consent items. PMC will be hosting a Business After Hours on April 3<sup>rd</sup> from 5:30-7:00 PM. Also, Hillbilly Days will be April 17<sup>th</sup> - 19<sup>th</sup> and City Hall will be closed to assist with traffic control.
