# CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES May 8, 2017 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, May 8, 2017. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

There being a quorum present, Mayor James A. Carter called the meeting to order at 6:00 p.m. Commission Members present at roll call were as follows:

#### **MINUTES**

The minutes for the previous regular meeting held on April 24, 2017 were in each Commission Member's agenda package. There being no additions or corrections, Commissioner Hartsock made the motion to approve the minutes as prepared. Commissioner McNamee seconded the motion. Mayor Jimmy Carter called for discussion, there being none, the motion carried unanimously. 5-0.

## **BUSINESS FROM THE FLOOR**

Comments from Shelebra Bartley regarding joggers and runners downtown: Did not show.

Comments and recap of April 29<sup>th</sup>, 2017 Rally event: City Manager Blackburn says that there is a lot to be said about this event. The position of the City is to not take sides. We did take whatever steps necessary to protect our community. Peace was at hand and our first priority. There were numerous meetings and there was a lot of attention to this event. On Friday, we sent notices to citizens of what was required of a government entity. I've never been prouder of the agencies and the outpouring of the support from the community. Several agencies were involved and worked together to protect this community. Greatly appreciate everyone's cooperation. The leadership that our force showed was outstanding and the media did not do it

justice. Everyone and their actions, level of professionalism was one of my proudest moments of my life. I commend each department and I am proud of you all. Mayor Carter then says that he was just taken back by it all and very impressed by the way everyone took control of the situation. Everybody knew their assignments and it was outstanding work. Commissioner McNamee adds that he was amazed at how smooth it went and thanked everyone as well. Commissioner Hartsock said that these people chose to protect us and for that we owe you a big thank you. Commissioner Coleman says that he was impressed of how the city forces took charge of the situation. This event showed us what you are made of and you have my upmost respect. Commissioner Shurtleff wanted to thank everyone for what they did as well. Chief Edmonds came forward and said that Phillip and he started on this a few days out. He says that they were prepared for the worst but thankfully it turned out the way it did. Commissioner Coleman made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.

#### PAYMENT OF CITY BILLS

The City Manager Donovan Blackburn requested the approval to pay city bills in the amount of \$919,228.73. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0.

Philip Elswick was present and submitted several requests to the commission for approval.

1. Consider request to approve and authorize payment of invoice #16015-2, as submitted, with Urbanfabric for \$76,000.00 for architectural fees for

- the KY Enterprise Industrial Park Spec Building Project. Commissioner Shurtleff made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 2. Consider a request to authorize and approve payment of pay request #3, as submitted, from H2O Construction for \$15,592.00 for the sidewalk replacement project and to grant the Mayor the authority to sign and execute said pay request on behalf of the City of Pikeville. Commissioner Hartsock made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 3. Consider a request to authorize and approve payment of invoice #79035, as submitted, with Summit Engineering, Inc. for \$18,250.00 for the Marion Branch Ind. Park Access Road Project. Commissioner Hartsock made the motion to approve. Commissioner Coleman seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.

City Manager Donovan Blackburn presented the commission with the following items for approval:

Consider a request to authorize and approve the amended City of Pikeville Position Pay Chart dated 5-8-17, as submitted, amending the Police Chief rate and to appoint Chris Edmonds as the new Police Chief as recommended by the City Manager. Commissioner Hartsock made the motion to adopt. Commissioner McNamee seconded the motion. Mayor Carter called for comments and Chief Edmonds approached the Mayor and Commission. Chief Edmonds says that after 18 years of service, five Chiefs, there was a lot of learning experiences. In the last few years, he was under good leadership and he would like to continue what has been started. Mayor called for additional comments, there being none, the motion passed unanimously. 5-0.
- 2. Consider a request to authorize and approve a payment of \$202,289.80 for the payoff for the Series 2014 GO note for the Riverfill Seating Project Payoff. Commissioner McNamee made the motion to approve. Commissioner

Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.

- 3. Consider a request to reappoint Johnny Tackett and Randy Roberts to the City of Pikeville Vacant Property Review Board. Their new term shall expire on April 25<sup>th</sup>, 2021. Commissioner Hartsock made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 4. Consider a request to authorize and approve an advertisement for bids for a new excavator for the gas department. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 5. Consider a request to authorize and adopt the amended personnel policy 2.7, as submitted. Commissioner Hartsock made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 6. Consider a request to authorize and approve an Agreement, as submitted, between the City of Pikeville and BitSource, LLC, to permit the City Manager to amend the agreement if needed as long as it does not change the overall scope and to grant the Mayor the authority to sign and execute said agreement on behalf of the City of Pikeville. Commissioner McNamee made the motion to approve. Commissioner Coleman seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 7. Consider a request to authorize and approve a Construction Proposal, as submitted, for milling and asphalting an area on Hambley Blvd. for a total cost of \$18,582.60 and to grant the City Manager the authority to sign and execute the Construction Proposal on behalf of the City of Pikeville. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments and asked where on Hambley. Mr. Elswick said in front of Velocity where there was a water leak. Mayor called for additional comments, there being none, the motion passed unanimously. 5-0.
- 8. Consider a request to authorize and award an advertised bid, as submitted, to the low bidder Jigsaw Enterprises, for \$15,570.00 for gravel for the Pikeville Pavilion and to issue the notice to proceed for said project on behalf of the City of Pikeville. Commissioner Hartsock made the motion to approve. Commissioner Coleman seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 9. Consider a request to authorize and award an advertised bid for the City of Pikeville Wastewater Treatment Plant. Bid are due to be open Monday afternoon. Vaughn and Melton will submit recommendation of award during Monday night's meeting. Item was tabled for a special meeting Consider a request to call a special called city commission meeting for May 10 at 8:30 am to consider awarding the Waste Water Treatment Plant Bid and a few other items. Commissioner McNamee made the motion to approve.

- Commissioner Coleman seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 10. Consider a request to authorize and approve a software and license agreement, as submitted, with Logics for a total of \$50,935.00, authorizing minor changes to said agreement by City Manager & City Attorney, and to grant the Mayor the authority to sign and execute said agreements on behalf of the City of Pikeville. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 11. Pursuant to KRS 61.810, consider request for closed session for discussion of economic development, legal and personnel issues. Commissioner McNamee made the motion. Commissioner Coleman seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0.
- 12. Commissioner Coleman made the motion to reconvene. Commissioner Shurtleff seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0. Mayor called the session back into order.
- 13. Motion to appoint city employee Philip Elswick to the position of interim City Manager effect immediately to be under supervision and direction of City Manager Donovan Blackburn until such time as he leaves his employment with the City. Commissioner Coleman made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 14. Commissioner Coleman made motion to go back to closed session pursuant to KRS 61.810 for purpose of personnel discussion. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 15. Commissioner McNamee made the motion to reconvene. Commissioner Shurtleff seconded the motion. Mayor called for comments, there being none, the motion passed unanimously. 5-0. Mayor called the session back in order.
- 16. There being no further business to come before the Commission, Commissioner McNamee has made the motion to adjourn the meeting. Commissioner Coleman seconded the motion. Mayor Carter called for discussion, there being none, the meeting was adjourned. 5-0.
