CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES October 24, 2016 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, October 24, 2016. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

MINUTES

The minutes for the previous regular meeting held on October 10, 2016 were in each Commission Member's agenda package. There being no additions or corrections, Commissioner Huffman made the motion to approve the minutes as prepared. Commissioner Justice seconded the motion. Mayor Jimmy Carter called for comments, there being none, the motion passed unanimously. 5-0.

BUSINESS FROM THE FLOOR

Consider a request to authorize and adopt a proclamation in recognition and honor of the Pikeville High School Junior Chef's Team accomplishments. Commissioner Huffman made the motion to approve. Commissioner Chaney seconded the motion. Mayor Carter called for comments and asked that the Coach and the members come forward. Each Commission member expressed their excitement to see a culinary program at the High School and congratulated them on their outstanding performance. The Coach for the program was very excited to receive the recognition and very proud of her students. Mayor Carter called for additional comments, there being none, the motion passed unanimously. 5-0.

PAYMENT OF CITY BILLS

Philip Elswick was present and submitted several requests to the Commission for approval.

Consider request to approve and authorize change order #1, as submitted, with Jigsaw Enterprises, LLC for an increase of \$1,500.00 for the York House Site Improvement Project to straighten the rock wall fence and to grant the Mayor the authority to sign and execute said change order on behalf of the City of Pikeville. Commissioner Justice made the motion to approve. Commissioner Chaney seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 2. Consider a request to authorize and approve payment of invoice #5858, as submitted, with Jigsaw Enterprises, LLC for \$19,421.20 for the York House Site Improvement Project. Consider a request to authorize and approve payment of pay request #1, as submitted, by Craine Construction for \$13,575.00 for the York House Exterior & Interior Improvement Project and to grant the Mayor the authority to sign and execute said pay request on behalf of the City of Pikeville. Commissioner Chaney made the motion to approve. Commissioner Justice seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 4. Consider a request to authorize and approve payment for pay request #2, as submitted between Eastern Tank and Utilities for \$11,550.00 for the Bob Amos Water Tank Storage Rehabilitation Project and to grant the Mayor the authority to sign and execute said pay request on behalf of the City of Pikeville. Commissioner Huffman made the motion to approve. Commissioner Chaney seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.

Commissioner Chaney made the motion to approve. Commissioner Coleman seconded the motion. Mayor Carter called for comments, there being none, Mayor called roll call.

Consider a second reading and adoption of ordinance #0-2016-017 declaring the intention of the City of Pikeville to annex certain unincorporated territory lying adjacent to the present city corporate limits and comprising of approximately 24.13 acres extending the city's corporate limits on the south end of the existing corporate limits along the Levisa Fork of the Big Sandy River on parts of Smiley Fork and Fords Branch and to grant the Mayor the authority to sign and execute said ordinance on behalf of the City of Pikeville. Commissioner Chaney made the motion to approve. Commissioner Huffman seconded the motion. Mayor Carter called for comments, there being none, Mayor called roll call.

City Manager Donovan Blackburn presented the Commission with the following items for approval:

Nick will replace Cory Baker who has tendered his resignation. Commissioner Justice made the motion to adopt. Commissioner Huffman seconded the motion. Mayor Carter called for comments. Nick Potter approached the Commission and said that he missed his career as a firefighter and he appreciates the opportunity to come back. City Manager says that we are certainly glad to have him back. Mayor Carter called for additional comments, there being none, the motion passed unanimously. 5-0.
- 2. Consider a request to authorize and approve Addendum #2, as submitted, between Summit Engineering, Inc. and the City of Pikeville for professional services relative to the New Bridge and Approaches from US23 to Marion Branch Industrial Park and to grant the Mayor the authority to sign and execute said addendum on behalf of the City of Pikeville. Commissioner Justice made the motion to approve. Commissioner Coleman seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.

- 3. Consider a request to authorize the advertisement and posting for the position of Tax Administrator. Grace Ratliff has announced that she will be retiring effective December 31, 2016 and will be dearly missed. Commissioner Huffman made the motion. Commissioner Chaney seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 4. Consider a request to authorize and approve payment of a Sales Contract, as submitted, between Inter Mountain Cable Inc. and the City of Pikeville for Fiber Ethernet Port Charge and service to the City Economic Development Office located at 773 Hambley Boulevard, Pikeville, Kentucky 41501 and to grant the Deputy City Manager Rebecca Hamilton the authority to sign and execute said contract on behalf of the City of Pikeville. Commissioner Justice made the motion to approve. Commissioner Coleman seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 5. Consider a request to authorize and adopt a resolution, as submitted, authorizing depository banks for the City of Pikeville, amending Rebecca Hamilton's title and to grant the Mayor the authority to sign and execute said grant on behalf of the City of Pikeville. Commissioner Huffman made the motion to approve. Commissioner Chaney seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 6. Consider a request to authorize and approve a professional consultant agreement between SMG and the City of Pikeville at a fee of \$1,500.00 per month through the month of April and to authorize the Mayor to sign and execute said agreement contingent upon the inspection and satisfaction of said agreement by the City Manager. Commissioner Huffman made the motion to approve. Commissioner Coleman seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 7. Pursuant to KRS 61.810, consider request for closed session for discussion of economic development, legal and personnel issues. Commissioner Justice made the motion. Commissioner Huffman seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0.
- 8. Commissioner Coleman made the motion to reconvene. Commissioner Justice seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0. Mayor called the session back into order.
- 9. Motion to authorize the City Manager and City Attorney to create a non-Profit corporation named "Eastern Kentucky Expo Center, Inc." for the purpose of operating the Eastern Kentucky Expo Center and all other lawful purposes; naming the Commissioners and Mayor as the Board of Directors, appointing the City Manager, Donovan Blackburn as CEO of the Corporation and to carry out all other acts necessary or convenient to establish the non-profit corporation. Commissioner Chaney made the motion to approve. Commissioner Huffman seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.

10. There being no further business to come before the Commission, Commissioner Huffman has made the motion to adjourn the meeting. Commissioner Chaney seconded the motion. Mayor Carter called for discussion, there being none, the meeting was adjourned. 5-0.
