## MINUTES OF June 10, 2014 MEETING OF THE PIKE COUNTY, KENTUCKY, CITY OF PIKEVILLE AND ELKHORN CITY JOINT PLANNING COMMISSION

WHEREAS, the Joint Planning Commission did meet on the lott day of June, 2014, as its regularly scheduled monthly meetings and did consider various items of business including a request by the Commission for the City of Pikeville to consider a text amendment to the City of Pikeville's zoning code amending Section 156.108(B), entitled C-3 Central Business District, to include as a permitted use the operation of a distillery and brewery and other appurtenant uses necessary to the distilling and brewing of alcohol beverages under license by the Kentucky Alcoholic Beverage Commission including sales thereof were permitted by State Law;

WHEREAS, prior to the Commission's meeting, a public hearing was held to consider comments on the proposed amendment to Section 156.108(B) after a notice of the hearing being duly published as required by law;

WHEREAS, the Commission has duly considered the comments of the public received during the public hearing;

WHEREAS, this Commission after considering the City of Pikeville's plan for development of a distillery and brewery in the downtown area of the City of Pikeville so to promote the growth of tourism, the arts, theater and overall economic benefit to the City and the region, the Commission does find that the City of Pikeville's proposed amendment to the text of its zoning code is beneficial to not only to the City of Pikeville, but also Pike County and the region in their joint goal to promote tourism and economic growth without being harmful to the other existing permitted uses within the City of Pikeville C3 Central Business District;

NOW, THEREFORE, the Joint Planning Commission by motion duly adopted does hereby recommend to the Commission for the City of Pikeville that it amend Section 156.108(B) of the City of Pikeville's Zoning Code to allow as a permitted use the operation of a distillery and brewery along with any other appurtenant uses necessary to the distilling and brewing of alcoholic beverages under License issued by the Kentucky Alcoholic Beverage Commission including sales thereof where permitted by State Law.

Upon roll call vote, the above resolution was duly adopted by majority vote of the Joint Planning Commission this day.
