CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES September 11, 2017 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, September 11, 2017. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

There being a quorum present, Mayor James A. Carter called the meeting to order at 6:00 p.m. Commission Members present at roll call were as follows:

Consider a request to appoint an individual to fill the vacancy on the City of Pikeville Board of Commissioners. Mayor Carter announced that the position of City Commissioner will be Kimberly S. May-Downey. Commissioner McNamee made a motion to approve. Commissioner Shurtleff seconded the motion. Mayor called for comments and invited Mrs. May-Downey up for the swearing in ceremony. Upon congratulating Commissioner May-Downey, Mayor called for additional comments, there being none, the motion passed unanimously. 3-0.

MINUTES

The minutes for the previous regular meeting held on August 28, 2017 were in each Commission Member's agenda package. There being no additions or corrections, Commissioner McNamee made the motion to approve the minutes as prepared. Commissioner Shurtleff seconded the motion. Mayor Jimmy Carter called for comments, there being none, the motion carried unanimously. 4-0.

BUSINESS FROM THE FLOOR

Denise Thomas presented the Mayor and the Commissioners with an update on the Big Sandy Community and Technical Project. Ms. Thomas informed them that the bids were opened August 30th and came in over budget. At this time, efforts are

being put forth to secure additional funding for that project. Mayor thanked Ms. Thomas for the update and says that we are looking forward to getting this started.

PAYMENT OF CITY BILLS

The City Manager Philip Elswick requested the approval to pay city bills in the amount of \$557,997.99. Commissioner McNamee made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 4-0.

CITY ATTORNEY

Russell Davis was present and had the following items to read into record.

 Consider a first reading of an Ordinance No. O-2017-27, as submitted, amending Chapter 100 of the City of Pikeville Code of Ordinances Providing for Inclusion of a Rate for Basic Life Support Disposable Supplies. Second reading and passage of this ordinance will take place at the next scheduled meeting.

2. Consider a first reading of Ordinance No. O-2017-28, as submitted, amending the 2017-2018 Fiscal Budget. Second reading and passage of this ordinance will take place at the next scheduled meeting.

CITY MANAGER

City Manager Philip Elswick presented the commission with the following items for approval:

- 1. Consider a request to appoint a Mayor Pro-tem that shall serve on behalf of the Pikeville City Commission for the remainder of the 2017-2018 commission cycle. Mayor Carter made the motion to appoint Commissioner Shurtleff as Mayor Pro-tem. Commissioner McNamee seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 4-0.
- 2. Consider a request to appoint Ed Billips to fill the term of Mary Jane Younce who tendered her resignation and John Elliott to the Board of the Pikeville Housing Authority. Commissioner McNamee made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments and made the clarification that John Elliott is taking Dallas Layne's term. Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.
- 3. Consider a request to appoint Phillip Reed to the Physical Fitness Testing Committee for a term expiring on January 1, 2019. Commissioner McNamee

- made the motion. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 4-0.
- 4. Consider a request to authorize and approve an Anthem Blue Cross and Blue Shield Provider Agreement, as submitted, with the City of Pikeville for ambulance services and grant the Mayor to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments. City Attorney explains that this is a renewal and would recommend that we go ahead and pass this. Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.
- 5. Consider a request to authorize and approve insurance renewals, as submitted, for Anthem health, dental, and vision insurance as well as the Wellbeing Perks program and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments. Mr. Elswick says that there will be a 0% increase and no change, credit going to Emily on this. Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.
- 6. Consider a request to authorize and adopt a resolution, as submitted, in support of Pikeville Medical Center's application to the Economic Development Administration and act in cooperation as the co-applicant and grant the Mayor the authority to sign any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments. Denise Thomas explains that this involves the heart institute expansion and assist in the funding of the equipment. EDA came back with some restrictions and asked that local government be involved in the request and PMC has met federal regulations associated with these funds. She adds that multiple applications from the city can be considered. Mr. Elswick says that at this time we have no other EDA applications in. Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.
- 7. Consider a request to authorize and approve payment of an invoice for City Tire & Auto Center, as submitted, for \$3,500.00 for a 6-foot x 20-foot trailer, which was a capital budgeted item. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 4-0.
- 8. Consider a request to award an advertised bid, as submitted, to RG3 Meter Company for radio read water meters, \$680,150.00, and gas registers, \$111,996.00, authorize issuance of a Notice to Proceed upon securing all necessary funding, and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments. City Attorney says we have not yet awarded this bid. Commissioner May-Downey says that she would like an opportunity to review

- the bid. Mayor says that this will be subject to final review of documents between Kim, Rebecca, Rusty and Philip. Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.
- 9. Consider a request to authorize the advertisement for public bids for replacement of carpet and tile at City Hall. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 4-0.
- 10. Consider a request to authorize the advertisement for public bids for a wireless sound system for Main Street, Second Street, Caroline Avenue, Grace Avenue and Division Street. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments and adds that we have had a sound system for a while we are just upgrading and adding more streets. Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.
- 11. Consider a request to authorize the advertisement for public bids for the purpose of repairing various sections of city sidewalks. Commissioner McNamee made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments. Mr. Elswick says that the ordinance requires us to bid this annually. City Attorney explains that we have to set priority and spend, using best discretion with the money that we have. Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.
- 12. Consider a request to post and advertise for the position of Fireman/EMT. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments. Mr. Elswick says that we are down three and seeking to fill two positions. Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.
- 13. Consider a request to post and advertise for the position of Police Officer. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments. Mr. Elswick says that we will be replacing an officer who will be retiring in the spring. Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.
 - **Mayor Carter announces that PMC will be hosting a telethon starting Thursday at noon for hurricane victims. Also, mentions the consent items from the agenda.
- 14. Pursuant to KRS 61.810, consider request for closed session for discussion of economic development, legal and personnel issues. Commissioner McNamee made the motion. Commissioner Shurtleff seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 4-0.
- 15. Commissioner McNamee made the motion to reconvene. Commissioner Shurtleff seconded the motion. Mayor Carter called for discussion, there

- being none, the motion passed unanimously. 4-0. Mayor called the session back into order.
- 16. Consider a request to authorize and amend the City of Pikeville Pay Chart dated September 11, 2017, as submitted, and immediately assign Sandy Walters to the position of Accounts Payable and Payroll Clerk at the 10-year rate. Mayor Carter made the motion to approve. Commissioner McNamee seconded the motion. Mayor called for comments, there being none, the motion passed unanimously. 4-0.
- 17. There being no further business to come before the Commission, Commissioner McNamee has made the motion to adjourn the meeting. Commissioner May-Downey seconded the motion. Mayor Carter called for discussion, there being none, the meeting was adjourned. 4-0.
