CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES September 23, 2019 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, September 23, 2019. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

There being a quorum present, Mayor James A. Carter called the meeting to order at 6:00 p.m. Commission Members present at roll call were as follows:

MINUTES

The minutes for the previous regular meeting held on September 9, 2019 were in each Commission Member's agenda package. There being no additions or corrections, Commissioner Hartsock made the motion to approve the minutes as prepared. Commissioner McNamee seconded the motion. Mayor Jimmy Carter called for discussion, there being none, the motion carried unanimously. 4-0.

BUSINESS FROM THE FLOOR

Consider a request to adopt a proclamation, as submitted, regarding the 2020 Complete Count Census Committees of Pike County and the City of Pikeville and grant the Mayor to sign and execute said proclamation on behalf of the City of Pikeville. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor called for comments, there being none, motion passed unanimously. 4-0.

PAYMENT OF CITY BILLS

The City Manager Philip Elswick requested the approval to pay city bills in the amount of \$2,491,492.26. Commissioner McNamee made the motion to approve.

Brad Slone was present and submitted several requests to the commission for approval.

Consider a request to authorize and approve termination, in full or in part, of a Memorandum of Understanding with the Commonwealth of Kentucky, Finance and Administration Agreement regarding installation of additional fibers for the City of Pikeville's use as part of the Kentucky Wired project, authorize and approve payment of KYWired Invoice No. 1 for \$86,011.00, and grant the Mayor the authority to sign and execute any and all necessary documents upon completion of negotiations by the City Manager and City

Attorney. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, motion passed. 4-0

CITY MANAGER

City Manager Philip Elswick presented the commission with the following items for approval:

Commissioner Powers made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments. Chief Bentley introduced the Firefighters/EMTs to the commission. Bentley stated they will be taking the CPAP testing in Indianapolis on October 19, and after passing, they will begin a Fire Academy working on EMT certification up to firefighting certification. Chief Bentley stated these new hires will bring staffing to 9 per shift. Mayor Carter called for additional comments, there being none, motion passed unanimously. 4-0.
- 2. Consider a request to authorize and approve a proposal with Municity Software Consulting Associates, as submitted, for an online tax status portal, at no cost to the City, and grant the Mayor the authority to sign and execute said contract upon completion of negotiations by the City Manager and City Attorney. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 4-0.
- 3. Consider a request to authorize and approve a Kentucky Power Company Contribution-In-Aid-Of-Construction Agreement for Electric Distribution for the Overlook Events Center project, as submitted, authorize and approve payment of \$27,993.63, and grant the Mayor the authority to sign and execute any and all necessary documents upon completion of negotiations by the City Manager and City Attorney. Commissioner Hartsock made the motion to approve. Commissioner Powers seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 4-0.
- 4. Consider a request to authorize and approve payment of BitSource, LLC Invoice No. 856, as submitted, for \$530.00 for upgrades to the visitpikeville.com site and mobile application and grant the mayor the authority to sign and execute any and all necessary documents. Consider a request to award a contract to Jigsaw Enterprises, the lowest and best proposal, for the APP Plaza Improvements project for a fee not to exceed \$109,000 and grant the Mayor the authority to sign and execute any and all necessary documents. Mayor Carter called for discussion, there being none, the motion passed unanimously. 4-0. Mayor called the session back into order.
- 13. Consider a request to authorize and approve retirement of Yalo from the Pikeville Police Department due to health issues and transfer ownership to Josh Lawson, Yalo's handler, to alleviate separation hardship between the

dog and its handler and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor called for comments, there being none, motion passed. 4-0
