CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES February 25, 2019 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, February 25, 2019. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

There being a quorum present, Mayor James A. Carter called the meeting to order at 6:00 p.m. Commission Members present at roll call were as follows:

MINUTES

The minutes for the previous regular meeting held on February 11, 2019 were in each Commission Member's agenda package. There being no additions or corrections, Commissioner Hartsock made the motion to approve the minutes as prepared. Commissioner Shurtleff seconded the motion. Mayor Jimmy Carter called for discussion, there being none, the motion carried unanimously. 4-0.

BUSINESS FROM THE FLOOR

Proclamation honoring Pikeville High School Dance Team for its accomplishment of being named state champion and grant the Mayor the authority to sign and execute said proclamation on behalf of the City of Pikeville. Commissioner Hartsock made the motion to approve. Commissioner Powers seconded the motion. Mayor Carter called for comments and asked for the Seniors of the team to come forward and one of the ladies read the proclamation aloud. After the reading, Mayor and the Commission congratulated them on their achievements. Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.

Consider a request to adopt a proclamation honoring Pikeville Jr. High Scholl 7th Grade Boys Basketball Team on its accomplishment of winning the county championship and grant the Mayor the authority to sign and execute said

proclamation on behalf of the City of Pikeville. Commissioner Hartsock made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments and invited the Captain for the team to read the proclamation aloud. After the reading, Mayor and the Commission congratulated the boys on their success of the season. Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.

Presentation by PHS Teens Who Care United. Mrs. Scott and Bailey Lovern came before the Mayor and Commission to talk about the mentoring programs that they have been working with Commissioner Reed and the First Responders on. They explained that they focus on the positive peer pressure rather than the negative and ways to cope. Commissioner Reed says that this is a great opportunity to partnership and bond with the students. Mrs. Scott also presented a display banner to be placed at the entrances of the pond to show care for the environment.

PAYMENT OF CITY BILLS

The City Manager Philip Elswick requested the approval to pay city bills in the amount of \$1,541,185.74. Commissioner Hartsock made the motion to approve. Commissioner Powers seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 4-0.

Brad Slone was present and submitted several requests to the commission for approval.

Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.

Consider a request to authorize and approve Integrated Engineering Invoice No. 4210, as submitted, for \$5,245.00 for the Kentucky Avenue/Elm Street Pedestrian Improvements Project and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Shurtleff made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 4-0.

Consider a request to authorize and approve Judy Construction Company Pay Application No. 18, as submitted, for \$506,271.57 for the Wastewater Treatment Plant Improvements Project and grant the City Manager or Deputy City Manager of Operations/City Engineer the authority to sign and execute any and all necessary documents. Commissioner Hartsock made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 4-0.
- 5. Consider a request to authorize and approve Vaughn & Melton Consulting Engineers, Inc. Invoice No. 53, as submitted, for \$30,426.19 for the Wastewater Treatment Plant Improvements Project and grant the City Manager or Deputy City Manager of Operations/City Engineer the authority to sign and execute any and all necessary documents. Commissioner Hartsock made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments. City Manager explains that this is a Vaughn & Melton standard inspection contract. Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.
- 6. Consider a request to authorize and approve payment of Rising Sun Developing, Inc. Revised Payment Application No. 11, as submitted, for \$163,825.78 for the KEIP Speculative Building-Building Package Project and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Powers made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 4-0.
- 7. Consider a request to authorize and approve payment of Rising Sun Developing, Inc. Revised Payment Application No. 12, as submitted, for \$325,912.09 for the KEIP Speculative Building-Building Package Project and grant the Mayor the authority to sign and execute any and all necessary documents. Consider a request to authorize and approve KCTCS Grant No. GRT44860 (ARC funds) Invoice No. 2, as submitted, for \$248,534.91 for the Broadband Technology Center and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Powers made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments. City Manager says that this item and the next are the same project with the same amount of money for grant funds for Broadband. Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.
- 10. Consider a request to authorize and approve KCTCS Grant No. GRT44861 (CDBG funds) Invoice No. 2, as submitted, for \$248,534.91 for the Broadband Technology Center and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Hartsock made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 4-0.

Commissioner Powers made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments. City Manager says that they are debating on whether to do three separate murals or one large mural. Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.

- Commissioner Shurtleff seconded the motion. Mayor Carter called for comments. City Attorney says that this has been discussed before. Back when the facility was built we did a subordination agreement. With this new project at the Y we are doing a second subordination agreement. Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.
- 7. Consider a request to transfer a 2005 Kenworth Rear Load Garbage Truck, VIN 2NKMHD8X85M118471 to the Pike County Fiscal Court and grant the City Manager the authority to sign and execute any and all necessary documents. Commissioner Shurtleff made the motion to approve. Commissioner Powers seconded the motion. Mayor Carter called for comments. City Manager says that the county has a need for this. Mayor called for additional comments, there being none, the motion passed unanimously. 4-0.
- 8. Consider a request to authorize the Human Resources Manager to advertise the position of Traffic Control Officer. Commissioner Hartsock made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments. City Manager says that we hired someone for about three weeks and he has taken another job. Consider a request to authorize and approve issuance of a letter of support and adoption of a resolution for PMC's Partnership for Opportunity and Workforce and Economic Revitalization grant application and grant the Mayor the authority to sign and execute any and all necessary documents.
