CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES April 25, 2022 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, April 25, 2022. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

There being a quorum present, Mayor James A. Carter called the meeting to order at 6:00 p.m. Commission Members present at roll call were as follows:

MINUTES

The minutes for the previous regular meeting held on April 11, 2022 were in each Commissioner's agenda package. There being no additions or corrections, Commissioner McNamee made the motion to approve the minutes as prepared. Commissioner Powers seconded the motion. Mayor Jimmy Carter called for discussion, there being none, the motion carried unanimously. 4-0.

BUSINESS FROM THE FLOOR

John Binkley with Accelecom was present and addressed the Commission regarding Ordinance No. O-2022-04, which creates telecommunications franchises. Mr. Binkley requested that the Commission reconsider the annual franchise fee minimum of \$25,000 and suggested that it be decreased to \$5,000 annually. Mr. Binkley indicated that an annual minimum of \$25,000 would prohibit some providers from entering the market thereby reducing competition. Mr. Binkley indicated that the companies that would be that would be prohibited were primarily small companies that would seek to serve only a few customers.

Pikeville Police Department & Fire Department - Hillbilly Days Reports:

Police Chief Michael Riddle stated the Police Department responded to 199 calls of service during the festival and that 564 permits were issued out as part of the festival.

Fire Chief Patrick Bentley stated the Fire Department responded to 126 calls along with additional walk ups to the EMS carts that were not logged.

Mayor Carter thanked all City Employees and UMG for an outstanding job they did during the Hillbilly Days Event.

PAYMENT OF CITY BILLS

The City Manager Philip Elswick requested the approval to pay city bills in the amount of \$795,769.99. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 4-0.
