CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES January 24, 2022 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, January 24, 2022. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

MINUTES

The minutes for the previous regular meeting held on January 10, 2022 were in each Commissioner's agenda package. There being no additions or corrections, Commissioner McNamee made the motion to approve the minutes as prepared. Commissioner Powers seconded the motion. Mayor Jimmy Carter called for discussion, there being none, the motion carried unanimously. 5-0.

BUSINESS FROM THE FLOOR

Consider a request to adopt a proclamation in recognition of the Pikeville Rotary Club 70th Annual Pancake Day and grant the Mayor the authority to sign and execute said proclamation on behalf of the City of Pikeville.
