CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES June 27, 2022 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, June 27, 2022. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

There being a quorum present, Mayor James A. Carter called the meeting to order at 6:00 p.m. Commission Members present at roll call were as follows:

MINUTES

The minutes for the previous regular meeting held on June 13, 2022 were in each Commissioner's agenda package. There being no additions or corrections, Commissioner McNamee made the motion to approve the minutes as prepared. Commissioner Powers seconded the motion. Mayor Jimmy Carter called for discussion, there being none, the motion carried unanimously. 4-0.

BUSINESS FROM THE FLOOR

Main Street Director Minta Trimble and Treasurer Libby Carter were present to be recognized by the Commission for receiving the Economic Vitality award as presented by the state Main Street organization. The Economic Vitality Award is designed to recognize an organization's leadership in enhancing the economic competitiveness, and The Shoppes at 225 met the award criteria. Both were very grateful to the Commission for investing in The Shoppes at 225 and trusting them to make it work.

PAYMENT OF CITY BILLS

The City Manager Philip Elswick requested the approval to pay city bills in the amount of \$2,131,888.78. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 4-0.

CITY MANAGER

City Manager Philip Elswick presented the Commission with the following items for approval:

Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments. The City Manager explained the U.S. Army Corps of Engineers noted some cracking within the box culverts during its last levee inspection and directed that an engineer be retained to assess the structural integrity of the culverts. There being no other comments, the motion passed unanimously. 4-0
- 2. Consider a request to authorize and approve transfer of \$770,000.00 to Appalachian Tank, Inc., as submitted, from CDBG funds received for equipment procurement and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Powers seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 4-0
- 3. Consider a request to authorize and approve payment of Brushy Fork Leadership Institute Invoice No. PIKEVILLE-CD-2022-01, as submitted, for \$7,975.00 for completion of a Creative Arts District Strategic Plan and grant the Mayor the authority to sign and execute any and all necessary documents. City Attorney Davis explained that Altice has made no effort to correct the franchise defaults identified by the Commission over one year ago, and the liquidated damages now exceed \$1M. There being no other comments, the motion passed unanimously. 4-0

Consider a request to authorize and approve an engagement letter with Talcott Franklin P.C., the Webb Law Center PLLC, Franklin Scott Conway LLP, the Law Firm of Linda Ain, and Mitchell Law PLLC (appellate counsel) for representation in the civil suit against Cebridge Acquisition, LLC, Cequel III Communications II, LLC & Altice USA and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Hartsock made the motion to approve. Commissioner Powers seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 4-0
- 7. Consider a request to authorize and approve payment of KLC Invoice No. P-5252-2022-22264-0, as submitted, for \$192,209.23 for property insurance, KLC Invoice No. L5452-2022-22567-0, as submitted, for \$325,633.39 for liability insurance, KLC invoice No. W5452-2022-21597-0, as submitted, for \$207,108.21 for workers compensation insurance, authorize and approve the KLC General Insurance Trust Agreement and Workers Compensation Trust Agreement, select payment option No. 2, as submitted, and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 4-0
