CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES July 23, 2018 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, July 23, 2018. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

There being a quorum present, Mayor James A. Carter called the meeting to order at 6:00 p.m. Commission Members present at roll call were as follows:

MINUTES

The minutes for the previous regular meeting held on July 9, 2018 were in each Commission Member's agenda package. There being no additions or corrections, Commissioner McNamee made the motion to approve the minutes as prepared. Commissioner Hartsock seconded the motion. Mayor Jimmy Carter called for discussion, there being none, the motion carried unanimously. 5-0.

BUSINESS FROM THE FLOOR

Mayor Carter asked that Ms. Tackett with the Pikeville Senior Citizen Center come forward and he presented her with an annual grant check for the center.

Denise Thomas was present to present invoices on the BSCTC Broadband Technology project, reporting that the project is approximately 50% complete. Construction is going well and we predict it will be the end of the year before completion. We are requesting drawdowns from CDBG funding and ARC funding in the following amounts, with Commission approval:

Consider a request to authorize and approve payment of Vaughn & Melton Consulting Engineering Invoice No. 46, as submitted, for \$30,426.19 for inspection services associated with the WWTP Upgrade Project and grant the City Manager or Deputy City Manager for Operations/Engineer the authority to sign and execute any and all necessary documents. Mr. Slone adds that this is standard ongoing construction; this month has been the same identical amount as previous months. Mayor called for additional comments, there being none, the motion passed unanimously. 5-0.

for the Farmers Market and grant the Mayor the authority to sign and execute any and all necessary documents. All invoices will be paid with grant funds. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.

- 2. Consider a request to authorize and approve a license agreement, as submitted, with the Morehead State University Small Business Development Center for office space at the Office for Economic Development for a 1-year term and grant the Mayor the authority to sign and execute any and all necessary documents upon completion of negotiations by the City Manager and City Attorney. Commissioner Hartsock made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments. Mr. Slone adds that they will occupy one of the offices in the ED building a couple days a week. Mayor called for additional comments, there being none, motion passed unanimously. 5-0.
- 3. Consider a request to authorize and approve a Facilities Solutions Agreement, as submitted, with Cintas for the Pikeville Fire Department sanitation and cleaning supplies for a minimum fee of \$25.00/month for a term of 3-years and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments. Mr. Phillip Reed says that right now we go monthly and buy supplies. With this agreement, they will stock us on a monthly basis and there should be a significant savings as well. Consider a request to award management of the ziplines, river trails, and horse barn to MuddyBoots in accordance with the submitted Operations and Maintenance plan and grant the Mayor the authority to sign and execute any and all documents upon completion of negotiations by the City Manager and City Attorney. The contract will provide management for the remainder of the 2018 calendar year. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 5. Consider a request to award a proposal to demolish the city-owned structure at 224 Julius Avenue to the company giving the lowest quote and grant the Mayor the authority to sign and execute any and all necessary documents. **TABLED**

- 6. Consider a request to award a proposal to Jigsaw Enterprises, LLC to repair a slide located on Enterprise Drive near its intersection with Marion Branch Road at an hourly rate not to exceed a total of \$120,000.00 under the terms of Jigsaw's state contract and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 7. Consider a request to award a proposal to Tackett Builders for the installation of the Hambley Athletic Complex Training Building Roof Project for \$87,000.00 and grant the Mayor the authority to sign and execute any and all documents upon completion of negotiations by the City Manager and City Attorney. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 8. Pursuant to KRS 61.810, consider request for closed session for discussion of economic development, legal and personnel issues. Commissioner McNamee made the motion. - 9. Commissioner McNamee made the motion to reconvene. Commissioner Hartsock seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0. Mayor called the session back into order.
- 10. Consider a request to enter into an agreement with InterMountain Cable for use of the City's Downtown Underground Conduit subject to negotiation by the City Manager and City Attorney and grant the Mayor the authority to sign any and all necessary documents. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 11. Consider a request to authorize and approve a Change Order for S4 Water Sales and Service, LLC, as submitted, for the WTP Filter Rehabilitation Project and grant the Mayor the authority to sign and execute any and all necessary documents.
