CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES November 25, 2019 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, November 25, 2019. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

There being a quorum present, Mayor James A. Carter called the meeting to order at 6:00 p.m. Commission Members present at roll call were as follows:

MINUTES

The minutes for the previous special meeting held on November 12, 2019 were in each Commission Member's agenda package. There being no additions or corrections, Commissioner McNamee made the motion to approve the minutes as prepared. Commissioner Shurtleff seconded the motion. Mayor Jimmy Carter called for discussion, there being none, the motion carried unanimously. 5-0.

BUSINESS FROM THE FLOOR

Robyn Crouch, a Cedar Creek resident, thank the Commission for taking the complaints of the citizens of Cedar Creek regarding speeding seriously. Ms. Crouch asked that the Police Department re-start the patrols and enforcement actions that have taken place in the neighborhood in the recent months. Police Chief Chris Edmonds and Public Safety Commissioner Phillip Reed explained that the police department has not started enforcement or patrols in the neighborhood and provided numerical data regarding the number of speeding citations and extra patrols. Additionally, Ms. Crouch asked that the Commission consider a three-way stop at Cedar Hills Drive and placement of thermoplastic warning strips coming into the neighborhood. City Manager explained that those decisions are outside of the City's control as Cedar Creek is a state roadway.

PAYMENT OF CITY BILLS

The City Manager Philip Elswick requested the approval to pay city bills in the amount of \$5,152,988.91. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0.

Brad Slone was present and submitted several requests to the commission for approval.
