CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES AUGUST 22, 2022 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, August 22, 2022. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

There being a quorum present, Mayor James A. Carter called the meeting to order at 6:00 p.m. Commission Members present at roll call were as follows:

MINUTES

The minutes for the previous regular meeting held on August 8, 2022 were in each Commissioner's agenda package. There being no additions or corrections, Commissioner McNamee made the motion to approve the minutes as prepared. Commissioner Powers seconded the motion. Mayor Jimmy Carter called for discussion, there being none, the motion carried unanimously. 5-0.

BUSINESS FROM THE FLOOR

Judy Tackett, a resident of Bill King Hollow, presented the Commission with a complaint of the creek being washed out from the recent flooding in the area. Ms. Tackett asked if the City dip the creek and place rock baskets in the area to avoiding losing more land when high water occurred. Mayor Carter explained that the complaint and issue to fix would need to go before the Division of Water. City Attorney Davis explained the legal issues to the resident if the City did the work at said area.

PAYMENT OF CITY BILLS

The City Manager Philip Elswick requested the approval to pay city bills in the amount of \$1,101,467.30. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0.

Brad Slone was present and submitted several requests to the Commission for approval.

Consider a request to authorize and approve payment of Copperhead Environmental Consulting, Invoice No. 1203.03, as submitted, for \$692.00 for the Pikeville FEMA Hazard Mitigation Environmental Assessment project and grant the Mayor the authority to sign and execute any and all necessary documents. CITY MANAGER

City Manager Philip Elswick presented the Commission with the following items for approval:

Consider a request to award a bid to 911 Fleet and Fire Equipment, as submitted, for \$328,561.39 for the purchase of self-contained breathing apparatus, facemasks, cylinders, and voice amplifiers and grant the Mayor the authority to sign and execute any and all necessary documents contingent upon FEMA approval to proceed with purchase before grant announcement. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments. City Manager Elswick explained that there is a need to purchase this equipment soon in order to avoid expiration of airpacks, and FEMA will allow the purchase in advance with written permission, which has not yet been received. There being none, the motion passed unanimously. 5-0
- 2. Consider a request to award a bid to Atlantic Emergency Solutions, as submitted, for \$57,819.50 for the purchase of fire hose and grant the Mayor the authority to sign and execute any and all necessary documents contingent upon FEMA approval to proceed with purchase before grant announcement. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments. City Manager Elswick explained that there is a need to purchase this equipment soon as some hose is older, and FEMA will allow the purchase in advance with written permission, which has not yet been received. There being none, the motion passed unanimously. 5-0

Consider a request to adopt a resolution, as submitted, awarding a telecommunications franchise to OpenFiber Kentucky Company, LLC and grant the Mayor the authority to sign and execute any and all necessary documents. - 4. Consider a request to authorize and approve submittal of a letter to the U.S. Department of Agriculture, Rural Development, as submitted, accepting responsibility to pay all costs of construction for Fire Station No. 2 in excess of the \$500,000 loan and \$348,800 grant and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Powers made the motion. Commissioner Hartsock seconded the motion. Mayor called for comments, there being none, the motion passed unanimously. 5-0
- 5. Consider a request to authorize and approve a Use Agreement, as submitted, with Faith Life Ministries, Inc. for the Bob Amos Park baseball fields and grant the Mayor the authority to sign and execute any and all necessary documents upon completion of negotiations by the City Manager and City Attorney. Commissioner McNamee made the motion to approve.

- 6. Consider a request to hire Jordan Clemons to the position of Patrolman with the Pikeville Police Department at the starting rate of pay for said position. - 7. Consider a request to authorize and approve an easement agreement, as submitted, with Jeff & Tracie Vanderbeck for property along Kati Street for repair of drainage issues and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Powers made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, the being none, the motion passed unanimously. 5-0
- 8. Consider a request to designate Monday, October 31 from 6 pm to 8 pm for trick-or-treating in the City of Pikeville. Commissioner Hartsock made the motion to approve. - 9. Commissioner Shurtleff abstained. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0
- 12. Consider a request to adopt the amended City of Pikeville Pay Chart dated August 22, 2022 and adjust Tonya Taylor's rate of pay to the 12 year rate for Executive Director of Finance, Brad Slone's rate of pay to the 14 year rate for Deputy City Manager of Operations, and Emily Fields' rate of pay to the starting rate of pay for Director of Human Resources. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0
