# CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES OCTOBER 10, 2022 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, October 10, 2022. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

There being a quorum present, Mayor James A. Carter called the meeting to order at 6:00 p.m. Commission Members present at roll call were as follows:

#### MINUTES

The minutes for the previous regular meeting held on September 26, 2022 were in each Commissioner's agenda package. There being no additions or corrections, Commissioner McNamee made the motion to approve the minutes as prepared. Commissioner Hartsock seconded the motion. Mayor Jimmy Carter called for discussion, there being none, the motion carried unanimously. 5-0.

### BUSINESS FROM THE FLOOR

Consider a request to adopt a proclamation declaring October 24, 2022 as World Polio Day in the City of Pikeville and grant the Mayor the authority to sign and execute said resolution on behalf of the City of Pikeville. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, and Dr. Rakesh Sachdeva, member of the Pikeville Rotary Club, gave thanks to the City of Pikeville and Community Members on behalf of the Pikeville Rotary Club. Dr. Sachdeva thanked the City for providing the Overlook Events Center for monthly meetings. Mayor Carter called for additional comments, there being none, the motion passed unanimously. 5-0

### PAYMENT OF CITY BILLS

The City Manager Philip Elswick requested the approval to pay city bills in the amount of \$1,522,343.62. Commissioner Powers made the motion to approve.

Commissioner McNamee seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0.

#### CITY ENGINEER

Brad Slone was present and submitted several requests to the Commission for approval.

- Consider a request to authorize issuance of an advertisement for public bid for the Melvina Drive Culvert Replacement project. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 2. Consider a request to reject all proposals for engineering services received for the Pikeville Water Treatment Plant System Improvements project. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments. The City Engineer explained that the responding firm had partnered with a second firm, one of which was licensed in Kentucky, but neither firms provided any evidence of experience with similar project. There being no further comments, the motion passed unanimously. 5-0
- 3. Consider a request to authorize applying for KIA 2022 Cleaner Water Program grants for the Pikeville Water Treatment Plant Filter Subsurface Wash System Improvements project and the Cedar Creek Sewer Extension project and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Hartsock made the motion to approve. Commissioner Powers seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0
- 4. Consider a request to award a bid to Jones Contracting, LLC, the low bidder, as submitted, for \$51,510.00 for the Poor Farm Lift Station Refurbishment project and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0
- 5. Consider a request to award a proposal to Boyd Asphalt, which provided the lowest quote, as submitted, for \$19,680.00 for the Douglas Street Drainage Repair project and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Powers made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0
- 6. Consider a request to authorize and approve payment of Palmer Engineering, Invoice No. 1, as submitted, for \$14,767.50 for the Suspension Bridge project and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve.

Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0

Consider an emergency reading of Ordinance No. O-2022-16, as submitted, fixing a tax levy on real and tangible personal property and franchises and grant the Mayor the authority to sign and execute said ordinance on behalf of the City of Pikeville. Commissioner Hartsock made the motion to approve. Commissioner Powers seconded the motion. Mayor Carter called for comments, there being none, Mayor called for roll call:

- 4. Consider a first reading of Ordinance No. O-2022-18, as submitted, authorizing the sale and issuance of General Obligation Bonds, Series 2022B, to provide interim financing of the construction of Fire Station No. 2 at Yorktown Landing.
- 5. Consider a first reading of Ordinance No. O-2022-19, as submitted, amending Section 92.99 related to Public Nuisances.
- Consider a first reading of Ordinance No. O-2022-20, as submitted, authorizing issuance of General Obligation Bonds, Series 2022C for the purpose of constructing Fire Station No. 2 at Yorktown Landing.

- 2. Consider a request to authorize and approve a Vending Service and Equipment Agreement with Paul Stambaugh and Lori Stambaugh, as submitted, for placement of vending equipment on City of Pikeville owned property and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0
- 3. Consider a request to award a proposal to Georgia Western, as submitted, for \$8,850.00 for refurbishment and reinstallation of an actuator associated with the flood control system and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0
- 4. Consider a request to authorize and approve Institute for Service Research Invoice No. 221007-822, as submitted, for \$7,656.00 for the Demand Estimation and Site Selection Study for additional conference space and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Hartsock made the motion. Commissioner McNamee seconded the motion. Mayor called for comments, there being none, the motion passed unanimously. 5-0
- 5. Consider a request to authorize the Director of Human Resources to post the position of Lieutenant and Battalion Chief at the Pikeville Fire Department. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comment, there being none, the motion passed unanimously. 5-0
- 6. Consider a request to award a proposal to Western Construction, Inc. for \$186,125.00 for the Cedar Creek Overpass Utility Line Refurbishment project and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Powers made the motion to approve. Commissioner Hartsock seconded the motion. Commissioner McNamee abstained. Mayor Carter called for comments. The City Manager explained that work on the utilities could not begin until the spring with warmer weather, but it is necessary to procure the contractor now as they will be assisting with the KYTC encroachment permit, preparation of traffic control plans, etc. There being none, the motion passed unanimously. 4-0
- 7. Consider a request to authorize and approve submittal of a grant application to the Kentucky Tourism, Arts, and Heritage Cabinet for \$60,000.00 in conjunction with numerous tourism commissions throughout the state. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, there being none, the motion unanimously. 5-0
- Consider a request to authorize and approve an agreement with Ramsey Pike LLC to reimburse the cost of utility work/relocation at Weddington Branch,

estimated to be \$37,500.00, as part of the stream restoration work necessary due to flooding and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Powers seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0

of discussion of economic development, legal, and personnel issues.
Commissioner McNamee made the motion to approve. Commissioner
Hartsock seconded the motion. Mayor Carter called for comments, there being

- 10. Consider a request to reconvene the meeting out of closed session into regular session. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 4-0
- 11. Consider a request to purchase road salt from Compass Minerals for \$120.52/ton and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 4-0
- 12. There being no further business to come before the Commission, Commissioner McNamee has made the motion to adjourn the meeting. Commissioner Hartsock seconded the motion. Mayor Carter called for discussion, there being none, and the meeting was adjourned. 4-0.
