At a regular adjourned meeting of the Common Council of the city of Pikeville, Kentucky, convened and held at the city hall in said city on the 21st day of October 1931, the following were present, Mayor, F.A. Connolly, Councilmen, Rush Sword, G.H. Francisco and Stafford Sowards.

ORDERED THAT:

Main Street Service Station be allowed the sum of One and 40/100 (\$1.40) Dollars, for bill of 8-31-1931, payable out of Fire Dept. Budget Fund.

ORDERED THAT:

C.&O. Railway Company be allowed the sum of Six (\$6.00) Dollars, for demurrage on two cars of Asphalt, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Garfield Sowards be allowed the sum of Fifty Five (\$55.00) Dollars, for extra work on street cleaning, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Rush Sword be allowed the sum of Nine and 60/100 (\$9.60) Dollars, for freight and painting bills paid, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Albert Bartley be allowed the sum of Eighteen (\$18.00) Dollars, for special traffic officer for 6 days \$3.00 per day, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Earl Adkins be allowed the sum of Eighteen (\$18.00) Dollars, for 6 days service as Special Traffic Officer at \$3.00 per day, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Otto Lawson be allowed the sum of Fifteen (\$15.00) Dollars, for five days service as Special Traffic Officer at \$3.00 per day, payable out of General Expenditure Budget Fund.

ORDERED THAT:

H.K. McCormack, be allowed the sum of Three Hundred Seventy Eight and 05/100 (\$378.05) Dollars, for payroll of men working on second street, payable out of General Expenditure Budget Fund.

ORDERED THAT:

J.C. Williamson be allowed the sum of Four (\$4.00) Dollars, for labor of men working on sidewalks on cline street, payable out of General Expenditure Budget Fund.
