

At a regular adjourned meeting of the Common Council of the City of Pikeville Kentucky, held in the city hall in the City of Pikeville, Kentucky, on the 22nd day of May, 1924 the following were present: Council men, J. G. Parker, Jerry Robinson, L. A. Duty, R. Thompson, K. J. Day and A. T. Ratliff.

Upon motion made, duly seconded and carried J. G. Parker was elected mayor pro tem.

Jerry Robinson moved that the city clerk write the Chesapeake and Ohio Railway Company officials for permit to cross railroad right of way at eastern end of Julius Avenue in the City of Pikeville which is now railroad crossing on upper end of College Street. A. Duty seconded said motion, which carried.

The committee appointed May 20, 1924, to examine C. C. Bowles building on Main Street recently damaged by fire, filed the following report, which was read to council, and which is as follows:

"We, the committee appointed by the Hon. Council of the City of Pikeville, Ky., May 20<sup>th</sup>, 1924, beg to make our report as follows:  
After investigating and examining the C. C. Bowles property on Front Street adjoining the Daily Night National Bank and J. G. Parker & Dick Scott we find and agree that the property is more than 50% damaged, and that it would be dangerous and hazardous to the adjoining property and the town in general.

C. C. Bowles appeared in open council, and offered in evidence the following witnesses in support of his application for permit to repair his building on Main Street recently damaged by fire: C. C. Bowles, H. Penley, W. P. Fuller, Jack Elswick, W. T. Hoffman and L. C. Smith.

Said witnesses were duly sworn by the city clerk, and the Council refused to hear said testimony.

K. J. Day moved that the above report of the Committee to wit John A. Bentley, C. C. Little and R. O. Horsader be accepted, which committee was appointed to investigate the property of C. C. Bowles which has been partly destroyed by fire. Said that the Council refuse to grant the permit to repair the building. Jerry Robinson seconded said motion, upon roll call the vote was as follows: K. J. Day, yes; Jerry Robinson, yes; R. Thompson, yes; L. A. Duty, yes; A. T. Ratliff, yes. Said motion carried.

K. J. Day moved that the city attorney be instructed to proceed in the morning with an injunction enjoining C. C. Bowles from repairing the building for which the permit has been refused, being the C. C. Bowles frame building on Main Street recently damaged by fire. Jerry Robinson seconded said motion, which carried.

Jerry Robinson moved that the citizens of Pikeville or any number thereof, be permitted to use the streets of Pikeville, at their expense. K. J. Day seconded said motion, which carried.

Jerry Robinson introduced an ordinance entitled "An ordinance blocking C. C. Bowles' frame building on Main Street, a nuisance and condemning same as such, and requiring same to be removed" after moved that said ordinance be passed and adopted. K. J. Day seconded said motion, upon roll call the vote was as follows: Jerry Robinson, yes; R. Thompson, not voting; L. A. Duty, not voting; K. J. Day, yes; A. T. Ratliff, yes. Said motion carried.

Upon motion made, duly seconded and carried council is adjourned until its next regular meeting.

At a regular meeting of the Common Council of the City of Pikeville, Kentucky, held in the city hall in the City of Pikeville, Kentucky, on the 3rd day of June, 1924, the following were present: Mayor L. A. Thompson and Councilmen Jerry Robinson, K. J. Day, L. A. Duty, J. G. Parker and R. Thompson.

The minutes of the meetings of May 6<sup>th</sup> and May 20<sup>th</sup>, 1924, were read and approved.

Bid of Campbell Construction Company for paving of Julius Avenue was filed and read to the Council.

Jerry Robinson moved that said above bid be passed over until next meeting and until Council hears from Chesapeake and Ohio Railway Company with reference to going over its property at end of Julius Avenue. L. A. Duty seconded said motion, which carried.

The matter of installing sewerage in alley running parallel with and between Third and Fourth Streets is referred to the Street Committee.

Robert Williams, John Scott, Chero-Cola Bottling Company and Pikeville Grocery Company are given notice not to hand over and load upon side walks in front of and adjoining their places of business.

Jerry Robinson moved that the National Audit Company be allowed the sum of \$372.80 for auditing books of City of Pikeville during December 1923 and January 1924. R. Thompson seconded said motion, which carried.

Therefore ordered that  
The National Audit Company be and it is hereby allowed the sum of \$375.00 for auditing books of the city of Pikeville during December, 1923, and January, 1924, which is in full.

Various property owners, owning property abutting alley running parallel with and between College Street and railroad right of way, appeared in open Council and addressed it with reference to paving of same some being for and some against same, upon motion made, duly seconded and carried said matter was referred to the Street Committee.

Ordered that

G. C. Rouse be and he is hereby allowed the sum of \$117.75 for committing releasing and dieting city prisoners in full from December 19, 1923, to May 26, 1924.

Ordered that

Frank L. Haynes be and he is hereby allowed the sum of \$148.00 for engineering services relative to city work during month of May, 1924.

Upon motion of Jerry Robinson, duly seconded by K. J. Day and carried, John A. Bentley, chief of the City Fire Department, is authorized to purchase five hundred (500) feet of fire hose for city on best possible terms,

upon motion of Jerry Robinson, duly seconded by K. J. Day and carried, it is ordered that the city advertise for bids for building of side walks on upper end of College Street abutting property of Pikeville College, Mrs. Harriet Taylor, Mrs. Dixie Taylor and Mrs. Hope Williamson.

Ordered that

Hiram Anderson be and he is hereby allowed the sum of \$200.00 for salary as street cleaner for month of May, 1924.

Ordered that

W. L. Ratliff be and he is hereby allowed the sum of \$50.00 for salary as city attorney for May, 1924.

Ordered that

James Motney be and he is hereby allowed the sum of \$135.00 for salary as chief of police for month of May, 1924.

Ordered that

John Fletcher be and he is hereby allowed the sum of \$67.00 for salary and services as city clerk for May, 1924.

Ordered that

R. M. Thompson be and he is hereby allowed the sum of \$125.00 for salary as policeman for month of May, 1924.

Ordered that

J. P. Marrs be and he is hereby allowed the sum of \$60.00 for salary as police judge for month of May, 1924.

Ordered that

J. P. Marrs be and he is hereby allowed the sum of \$400.00 for clerk hire for police judges office for month of May, 1924.

Ordered that

D. O. Graham be and he is hereby allowed the sum of \$31.25 for salary as city treasurer for month of March, April and May, 1924.

Upon motion made duly seconded and carried Council is adjourned until its next regular meeting.

At a regular meeting of the Common Council of the City of Pikeville, Kentucky, held in the city hall in the City of Pikeville, Kentucky, on the 17th day of May, 1924, the following were present: Mayor Z. A. Thompson and councilmen, Jerry Robinson, L. A. Duty, K. J. Day and R. Thompson.

Upon motion of K. J. Day, duly seconded by Jerry Robinson and carried, it is ordered that Kentucky and West Virginia Power Company be allowed vouchers or warrants monthly for light for city's use instead of quarterly; and it is further ordered that said monthly vouchers be divided into two equal vouchers or warrants.

Upon motion of Jerry Robinson, duly seconded by K. J. Day and carried, the Kentucky and West Virginia Power Company is directed to install one additional street light at intersection of Elm and Bank Streets.

Jerry Robinson introduced an ordinance entitled "An ordinance prohibiting the defacing of, or posting of bills on or mutilation of any pole used by any company or individual owning a franchise in the Town of Pikeville, Kentucky," and moved that said ordinance be passed and adopted. L. A. Duty seconded said motion, upon poll call the vote was as follows: Jerry Robinson yes; L. A. Duty, yes; K. J. Day, yes; R. Thompson, yes; J. G. Parker, absent; A. J. Ratliff, absent. Said motion carried, and said ordinance was passed and adopted.

Jerry Robinson introduced a resolution, entitled "A Resolution for the improvement of a portion of South Hillier Street, alley extending north and south between College Street and C. D. O'Reilly Co. Right of way to the south property line of A. J. Ratliff; alley between J. L. Morgan, Ireland Family, et al., property to
