At a regular meeting of the Common Council of the City of Pikeville, Ky., convened and held in the City Hall on the 1st day of February, 1927, the following were present: Mayor, J.P. Marrs; Councilmen, A.J. Akers, Millard Burke, L.A. Duty, S.H. Fields, and S.M. Hereford:

The minutes of the former meeting of the Common.Council, held on the 18th day of January 1927, are read and approved by the Council.

Green Charles having presented a claim asking for a rebate in the Street Improvement Assessment against him on property on the lower end of Main Street and Scott Avenue, and having at a former meeting presented evidence in support of said claim, and same having been laid over until this date, and the council having fully considered same, and the vote being taken on the rejection or approval of said claim which is as follows:

A majority having voted to disallow said claim, thereupon the Mayor declared said claim disallowed.

W.K. Steele appeared before the Council in open session and introduced proof on the request made by the firm of Picklesimer & Steele, that they be exonerated from paying certain tax tickets held by the Collector against them, for the years 1923 and 1924, and on motion, made, seconded and carried, the further consideration of this request is deferred until the next meeting of the Council.

On motion duly made, seconded and carried, the City Attorney, is directed to prepare an amendment to the Ordinance relative to Parking of motor vehicles on Second Street, passed at the last meeting of the council, gmending said Ordinance, so that when amended, same will not interfere with the Brooks Auto Co., in operating their Garage or in the sale of Gasoline, on Second Street, and have said amendment ready for consideration, at the next meeting of the Council.

Green Charles appeared in open council, and requested that the Mayor, appoint a Committee, composed of three citizens and tax payers of the City of Pikeville, Kentucky, to go upon the property of Green Charles, situated at the Lower end of Main Street and east end of Scott Avenue, and recently paved by the Campbell-Johnson Co., and assess the value of said property, the said Green Charles claiming that the cost of the paving amounts to more than 50 percent of the value of said property belonging to him, and abutting said paving.

Thereupon, on motion made seconded and carried, authorizing the Mayor to appoint the Committee asked for Mr. Green Charles, the Mayor appointed on said Committee, Tom Williamson, Dick Robinson, and Marvin Stratton.

The said Committee above named, will go upon the property of Green Charles situated at the lower end of main street and east end of Scott Avenue, and assess the value of said property, abutting the paving done recently by the Campbell-Johnson Company, and report their findings to this Council at its next regular meeting time, February, 15th, 1927.

J.J. Moore, appeared in open Council and stated that there was an error in the tax tickets, for the year 1926, of the Pikeville National Bank, The Day &. Night National Bank, and the First National Bank, in that they were charged at the rate of 75 cents on the \$100.00 on their bank shares, when in fact they should only be charged with a rate of 20 cents on the \$100.00 valuation of their Bank shares, and on motion made, seconded and carried, the further consideration of this matter is deferred until the next meeting of the council, and the City Attorney is directed to investigate this claim and make a report on same at the next meeting of the Council.
