

MINUTES } CITY OF PIKEVILLE

At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held at the City Hall in said city on the 19th day of April, 1927, the following were present: Mayor, J.P. Marrs, Councilmen: A.J. Akers, Millard Burke, S.M. Hereford, A.M. Phipps, Ed Wells and Richard Thompson.

The minutes of the former meeting of the council, held on the 5th day of April, 1927, are read by the Clerk and approved by the Council.

Capt. A.D. Roberts, appeared in person before the Council, and reported that he had made an Audit of the Water Department and of the City Records, for the year 1926, and read same to the Council.

Councilman, S.M. Hereford moved that the Audit presented and read by A.D. Roberts, be filed by the clerk and laid over for 30 days for further consideration by the Council, and said motion being duly seconded, upon a roll call of the council the vote was as follows:

The result of the vote being announced by the clerk, the Mayor declared said motion ~~carried~~ lost.

R.H. Sowards, Deputy U.S. Marshal, appeared before the Council, and presented an Execution against the City of Pikeville, Ky., and in favor of Kelley Bros. for Street Paving Bonds, issued in 1923, in the sum of \$13,371.99, and ask that the Council take some steps to pay this amount.

Councilman, S.M. Hereford, moved that the Mayor appoint a committee, to investigate and consider the matter of payment of the execution presented by R.H. Sowards, and report their findings at the next meeting of the council, and said motion being duly seconded, carried.

Thereupon, the Mayor, pursuant to the foregoing order, appointed, as a committee to investigate and consider the matter of payment of the execution presented by R.H. Sowards, Councilmen, S.M. Hereford and Ed Wells.

A.L. Ratliff, appeared before the Council and presented an Ordinance directing the laying of a Special Levy by the City Council, with which to pay the judgments of the Mountain Water Company and the Sandy Valley Light & Power Co., held against the City of Pikeville, Kentucky, and upon motion made, seconded and carried, the further consideration of the adoption of this Ordinance is postponed until the next regular meeting of the council.

Councilman, Richard Thompson, moved that the Mayor appoint Councilmen, Millard Burke and Ed Wells, as members of the Committee together with the Mayor, to employ Special Council for the City of Pikeville, Kentucky, and agree with him as to compensation for services, and said motion being duly seconded, upon a roll call of the Council, the vote was as follows:

The result of the vote being announced, by the Clerk, the Mayor declared said motion carried.

A.F. Childers appeared before the Council and asked that R.L. Sparks be exonerated of the payment of certain taxes to the City of Pikeville, Ky., on property owned by him and now owned by the said A.F. Childers and Thomps Phillips, for the years 1925 and 1926, and on motion made seconded and carried the further consideration of this matter, is postponed until the City Attorney can investigate the matter and make report to the Council on same, which shall be done at the next regular meeting.

Councilman, Ed Wells, moved that the City Attorney be directed to prepare an Ordinance declaring the barn on second street and owned by J.M. York, a Nuisance, and have same ready for the consideration by the Council, at its next regular meeting date, which carried.

The Street Committee ask the Council to grant it the privilege to repair the streets in certain places in the City of Pikeville, to be designated by the Street Committee, which privilege is granted.

Councilman, Millard Burke, moved that Bill Young be employed as Policeman, of the City of Pikeville, to fill out the unexpired term of said office, beginning January 5th, 1926, and ending January 1st, 1928, and there being no further nominations, upon a roll call of the Council the vote was as follows:

The result of the vote being announced by the Clerk, the Mayor declared said motion carried.

Thereupon, Bill Young, being present in open council, accepted said office of Policeman of the City of Pikeville, Ky., for the term ending January 1st, 1927, and presented bond as such Policeman, from the 19th day of April, 1927 to Jan. 1st, 1928, and took the oath of office as required by law.

Councilman, Millard Burke, moved that the bond presented by Bill Young, in the sum of \$1000.00, as Policeman, from April 19th, to Jan. 1st, 1928, with the Fidelity & Deposit Company as sureties be approved by the Council, and said motion being duly seconded, carried.

Said bond is in words and figures to-wit:

"THE FIDELITY AND DEPOSIT COMPANY OF BALTTMORE ,MARYLAND:
KNOW ALL MEN BY THESE PRESENTS:

That W.V. Young of Pikeville, State of Kentucky, hereinafter called the Principal, and the Fidelity and Deposit Company of Baltimore, Maryland, hereinafter called the Surety, a corporation organized under the laws of the State of Maryland, with its home office in the City of Baltimore, M.D., in the said State, are held and firmly bound unto The City of Pikeville, State of Kentucky, hereinafter called the Obligee, in the sum of One Thousand Dollars (\$1000.00) for the payment whereof to the Obligee the Principal binds himself, his heirs, executors, administrators, and assigns, and the Surety binds itself, its successors and assigns, jointly and severally, firmly by these presents. Signed, sealed and dated this 19th day of April, 1927.

WHEREAS the above named Principal has been duly authorized or elected to the Office of Policeman of the City of Pikeville, State of Kentucky, for the term of office beginning, April 19th, 1927, and ending January 5th, 1928 at which time his term off office ends or expires.

NOW THEREFORE, the conditions of the foregoing obligationis such that if the Principal shall faithfully perform such duties as may be imposed upon him by law and shall honestly account for all money that may come into his hands in his official capacity during the said term, then this obligation shall be void; otherwise it shall remain in force.

Councilman, Richard Thompson, moved that the City Attorney be directed to make and investigation and report at the next meeting of the Council, as to whether or not the City of Pikeville, Ky., can obtain judgements against the property owners who defaulted in the payment of their Street Paving Assessments, for work done by Kelley Brothers in 1913, and report his findings at the next meeting of the Council, and said motion being duly seconded, carried.

Councilman, S.M. Hereford, moved that it be declared and ordered by the Common Council of the City of Pikeville, Ky., that A.M. Phipps, is ineligible to hold the office of Councilman of the City of Pikeville, Ky., for the reason that he is not a legal resident of the City of Pikeville, Ky., having voted in Elkhorn City, Ky., at the November election, 1926, stating at the time, under oath, that Elkhorn City was his home and voting precinct, and that there is now existing a vacancy in the office of Councilman of the City of Pikeville, Kentucky, and said motion being duly seconded by A.J. Akers, upon a roll call of the Council the vote was as follows:

Pikeville Supply & Plaining Mill Co. be allowed the sum of Sixteen and 47/100 (\$16.47) Dollars, for Stakes, Nails &c. furnished City Engineer, as per bill of 4-13-1927.

5 ORDERED THAT:
J.J. Stone, be allowed the sum of One Hundred Forty Six and 47/100 (\$146.47) Dollars, as current expense account of Water Dept. for month of March, 1927, and freight bills, per itemized statement, payable out of water fund.

On motion made seconded and carried, Council is adjourned until the next regular meeting date, May 3rd, 1927, at 7:30 o'clock.
