

MINUTES } CITY OF PIKEVILLE

At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held on the 5th day of July, 1927, at the city hall in said city, the following were present: Mayor, J.P. Marrs, Councilmen, Millard Burke, S.M. Hereford, A.M. Phipps, Ed Wells, and Richard Thompson:

The minutes of all former meetings of the City Council are read and approved by the Council, not heretofore read and approved.

"Common City Council of the City of Pikeville, Kentucky, on the 22nd day of June, 1927, made, considered an ordinance providing a parking Ordinance on Division Street, which parking Ordinance handicaps a large percent of business on that street, and there I enter and veto the same, all of which I respectfully submit for the consideration of the Council, this 25th June, 1927.
