At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the City Hall of said city, on the 6th day of December, 1927, the newly elected members of the City Council, to-wit: Earl Brooks, Oscar Jackson, Rush Sword, E.E. Trivette, and Richard Thompson, presented their certificates of election as City Councilmen of the City of Pikeville, Kentucky, for the term beginning the first Monday in December, 1927, and said Certificates were filed by the City Clerk.
