At a regular adjourned meeting of the Dommon Council of the City of Pikeville, Kentucky, convened and held at the city hall in said city, on the 23rd day of March, 1928, the following were present; Mayor, Geo. Pinson Jr., Councilmen, Oscar Jackson, Rush Sword, and Richard Thompson.

The minutes of the former meeting of the Council are now read by the clerk, and approved by the Council.

Councilman, I.E. Brooks, now present:

on motion of Richard Thompson, duly seconded by I.E. Brooks, and carried, the City Tax Collector is directed to credit to the tax ticket now in his hands, against Bowles, Wright & Scott, with the sum of the ticket against F.C. Scott, for the year 1927, and paid by Bowles, Wright & Scott, under the impression that they were paying the proper bicket, and the City Tax Collector will obtain from M.G. Bowles, the duplicate tax ticket against F.C. Scott, which was turned over to him upon payment of same, under the misunderstanding above stated.

T.O. Robinson appeared before the Common Council and asked that he be exonerated from paying the taxes charged against him for the year 1927, by the city of Pikeville, Kentucky, for the reason that same has been charged against Mr. Mattingly, and paid by him, and the further consideration of this request is postponed until the next meeting of the Board, and the City Clerk is directed to investigate this matter and make a report an same at the next meeting of the Council.

Mrs. L. Nora Thornbury, City Assessor, appeared before the City Council, and recommended the appointment of George T. Thronbury, as Deputy City Assessor, of the City of Pikeville, Kentucky, and upon motion made and duly seconded and carried, the appointment of the said George T. Thornbury is approved and confirmed.

The said George T. Thornbury, being present in open council accepted said appointment, and took the oath of office as required by law.

Upon motion duly made, seconded and carried, W. Culbertson is exonerated from paying city taxes for the year 1925, in the sum of \$1.85, to the City of Pikeville, Kentucky, for the reason that he was not taxable in said city for said year.

Upon motion of Richard Thompson, duly seconded by Rush Sword, and carried, Geo. W. Doston, is exonerated from paying taxes to the city of Pikeville, Kentucky, for the year 1927, for city purposes, in the sum of \$5000.00, valuation, and being \$95.00, from the amount of the tax charged against him, divided as follows: From the General Fund \$37.50; Water Fund \$12.50, and from the Special Levy \$45.00. And the tax Collector is directed to deduct this amount from the face of said tax ticket for said year.

The Committee appointed to investigate the lighting conditions of Julius Avenue, asks that it be given further time in which to make final report, which is granted.

On motion, made, seconded and carried, W.E. Johnson is exonerated from paying the city taxes charged against him for the year 1927, by the city of Pikeville, Kentucky, for the reason that said property for which he is charged, is owned by K.J. Day, and that the said K.J. Day has already paid taxes on said property for said year.
