

MINUTES } CITY OF PIKEVILLE

At a regular adjourned meeting of the Common Council of the city of Pikeville, Pike County Kentucky, convened and held on the 7th day of June, 1928, in the city hall in said city, the following were present: Mayor, Geo. Pinson Jr., Councilmen, Oscar Jackson, Richard Thompson, and Rush Sword.

The minutes of all former meetings not heretofore read are now read and approved.

Councilmen, I.E. Brooks and E.E. Trivette now present and acting.

The resignation of B.A. Ratliff, as Councilman, is presented and read to the Council, and Rush Sword moved the acceptance of same, and said motion being duly seconded, by E.E. Trivette, carried by a unanimous vote.

Councilman, Rush Sword, nominated J.S. Cline, as Councilman, to fill the vacancy caused by the resignation of B.A. Ratliff, and there being no further nominations, upon a roll call of the council, the vote was as follows:

The result of the vote being announced by the clerk, the Mayor declared the said J.S. Cline elected as Councilman, of the city of Pikeville, Kentucky, to fill the vacancy caused by the resignation of B.A. Ratliff.

J.S. Cline being notified of said election as Councilman of the city of Pikeville, Kentucky, accepted said office, and took the oath of office as required by law, and entered upon his duties as Councilman.

The Mayor appointed J.S. Cline on the Street Committee, to fill the vacancy caused by the resignation of B.A. Ratliff, and the said J.S. Cline will fill all vacancies on all committees caused by the resignation of the said B.A. Ratliff.

The Street Committee is directed to interview the persons that now have the Street Cleaning contract with the city, and ascertain whether or not they want to continue with the work, or give up said contract, and they will report their findings at the next meeting of the Council.

The Contract directed to be prepared by the city attorney, between the city of Pikeville, Kentucky and Code Ramsey, as Traffic Officer, is presented and read to the council, and J.S. Cline moved that the further consideration of said contract be postponed until the next regular meeting of the Board, and said motion being duly seconded, carried by a unanimous vote.
