

MINUTES } CITY OF PIKEVILLE

At a regular meeting of the Common Council of the city of Pikeville, Kentucky, convened and held at the city hall of said city on the 19th day of June, 1928, the following were present, Mayor, Geo. Pinson Jr., Councilmen, I.E. Brooks, J.S. Cline, Rush Sword, and Richard Thompson,

The minutes of all former meetings not heretofore read and approved, are now read and approved by the Council.

Councilmen, ~~I.E. Brooks~~ Oscar Jackson and E.E. Trivette now present.

Councilman, J.S. Cline, moved that the bid of the Kentucky & W.Va. Power Company, and of S.M. Moore, on the light franchise, and the contract for Street Lights, offered for sale by the city, be rejected, and said motion was duly seconded by Richard Thompson, and upon a roll call of the council, the vote was as follows:

The result of the motion being announced by the clerk, the mayor thereupon declared said motion carried, and said bids rejected.

An ordinance entitled "AN ORDINANCE PROVIDING FOR THE SELLING AT PUBLIC BIDDING TO THE HIGHEST BIDDER OF THE FRANCHISE, RIGHTS AND PRIVILEGES OF ENTERING IN, THROUGH AND UNDER THE STREETS, ALLEYS PUBLIC WAYS, BRIDGES, SIDE WALKS, PARKS AND OTHER PUBLIC PLACES IN THE CITY OF PIKEVILLE, PIKE COUNTY KENTUCKY, TO LAY, CONSTRUCT MAINTAIN AND OPERATE GAS PIPES, MAINS AND ALL APPLIANCES AND APPURTENANCES NECESSARY THERETO FOR THE PURPOSE OF SUPPLYING, DISTRIBUTING AND SELLING NATURAL AND ORE ARTIFICIAL GAS TO SAID CITY OF PIKEVILLE, KENTUCKY AND TO INDIVIDUALS, FIRMS, CORPORATIONS AND OTHERS RESIDING OR LOCATED WITHIN THE CORPORATE LIMITS OF SAID TOWN FOR A PERIOD OF TWENTY YEARS: PRESCRIBING THE TERMS AND CONDITIONS THEREOF AND GRANTING SAID FRANCHISE, RIGHTS AND PRIVILEGES TO THE HIGHEST AND BEST BIDDER THEREFOR, HIS OR ITS SUCCESSORS AND ASSIGNS:" is presented and read to the Council, and J.S. Cline moved the adoption of same, and said motion being duly seconded by E.E. Trivette, upon a roll call of the council the vote was as follows:

The result of the vote being announced by the clerk, the Mayor, thereupon cast the deciding vote, and voted "Yes", and thereupon declared said motion carried and said ordinance adopted, and said franchise ordered sold by the city clerk.

On motion made seconded and carried the Mayor is authorized and directed to appoint a committee to investigate and report to the Council at its next regular meeting, on the franchise ordered to be sold by the above order.

The Mayor, pursuant to order of the council, appointed on said committee to investigate and report on the Gas Franchise, offered for sale, K.J. Day, F.L. Rice, Linton Trivette, R.G. Wells, and each member of the City Council.

Councilman, I.E. Brooks, moved that the sum of Thirteen Hundred and Ninety Five (\$1395.00) Dollars, be transferred from the Water Works account to the water bond account, for the purpose of meeting the requirements on the sinking fund account, and said motion being duly seconded by J.S. Cline, upon a roll call of the Council, the vote was as follows:

The City Clerk is directed to investigate ~~and report~~ the tax matters requested by W.P. Charles, and make such orders as is necessary to properly care for this question.

An ordinance entitled "AN ORDINANCE CREATING AND LEVYING A SPECIAL TAX TO PAY CERTAIN JUDGMENT INDEBTEDNESS AGAINST THE CITY OF PIKEVILLE, KENTUCKY, IN FAVOR OF KENTUCKY AND WEST VIRGINIA POWER COMPANY", is presented and read to the City Council, and J.S. Cline moved the adoption of same, and said motion being duly seconded by Rush Sword, upon a roll call of the council, the vote was as follows:

Millard Burke, presented a bid on the Street Cleaning Contract, at One Hundred Ninety (\$190.00) Dollars, per month, and upon motion made, seconded and carried, the further consideration of this matter is passed for further consideration.

A set of Police Regulations is presented and read to the Council, and J.S. Cline moved that the further consideration of this matter be postponed until the next meeting of the board, and said motion being duly seconded, carried.

The Mayor and the Street Committee is directed to consider the advisability of a change in the traffic regulations within the city, and they will report their findings to the Council at its next regular meeting.

On motion made seconded and carried, council is adjourned until June 20th, 1928.

At a regular adjourned meeting of the Common Council, of the city of Pikeville, Kentucky, convened and held on the 20th day of June, 1928, at the city hall in said city, the following were present: Mayor, Geo. Pinson Jr., Councilmen, I.E. Brooks, J.S. Cline, Rush Sword, and Richard Thompson.

Councilman, J.S. Cline, moved that the mayor appoint a committee, to investigate and report to the city council, whether or not there is any arrangements or contracts made, with the banks or either of them, to pay interest on the sinking fund money of the water department, deposited with them, and if not, make contracts with them, to receive the highest possible rate of interest obtainable on said fund, and report their findings to the next meeting of the council, and said motion being duly seconded, carried.

The Mayor, pursuant to the foregoing order, appointed on said committee, to report on Sinking Fund account of Water Department, Councilmen, J.S. Cline, and I.E. Brooks.

Councilman, J.S. Cline, moved that the City Attorney be directed, to notify the Southern Bell Telephone and Telegraph Company, to restore the original rates as set out in the original franchise, as sold by the city of Pikeville, Ky., and under which the Southern Bell Telephone & Telegraph Co., is now operating in said city, and said motion being duly seconded by Richard Thompson, upon a roll call of the council, they voted as follows:

The Committee appointed to investigate and report on the Street Cleaning Contract, asks for further time in which to make a final report, which is granted.
