

MINUTES } CITY OF PIKEVILLE

At a regular meeting of the Common Council of the City of Pikeville, Pike County, Kentucky, convened and held at the city hall in said city, on the 17th day of July, 1928, the following were present, Mayor, Geo. Pinson Jr., Councilmen, J.S. Cline, Oscar Jackson and Richard Thompson.

The minutes of former meeting of the council are read and ordered approved and signed:

Councilman, J.S. Cline moved that the City Attorney, John M. Hatcher, be ordered and directed to take steps to collect the delinquent water accounts, as shown by the audit of the water department, made by A.S. Johnson, as of January 1st, 1928, and said motion being duly seconded, carried by a unanimous vote.

Councilmen, Rush Sword and E.E. Trivette now present:

Two ordinances entitled "AN ORDINANCE RELATING TO THE MANNER OF THE ELECTION OF THE FOLLOWING OFFICERS FOR THE CITY OF PIKEVILLE, KENTUCKY, TO-WIT: MAYOR, POLICE JUDGE, CHIEF OF POLICE, CITY ATTORNEY, CITY CLERK, CITY TREASURER, CITY ASSESSOR AND CITY ENGINEER; AND PROVIDING FOR THEIR ELECTION AND SELECTION BY THE COMMON COUNCIL OF THE CITY OF PIKEVILLE, KENTUCKY; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH" and an ordinance entitled "

"AN ORDINANCE RELATING TO THE SALARIES OF THE FOLLOWING OFFICERS OF THE CITY OF PIKEVILLE, KENTUCKY, TO-WIT: MAYOR, CHIEF OF POLICE, DEPUTY POLICE OR POLICEMEN, POLICE JUDGE, CITY ATTORNEY, CITY CLERK, CITY TREASURER, CITY ASSESSOR, MEMBERS OF COMMON COUNCIL, AND CITY ENGINEER; AND FIXING THE SALARIES OF ALL OF SAID OFFICERS OF THE CITY OF PIKEVILLE, KENTUCKY; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH", is presented and read to the Common Council, and Councilman, J.S. Cline moved the adoption of said Ordinances and said motion being duly seconded by Richard Thompson, upon a roll call, the vote was as follows:

The result of the vote being announced by the Clerk, the Mayor, declared said motion carried.

The Street Committee makes report and asks that it be given further time in which to make final report on the bill presented by Mrs. N. Starkey, for repairing of alley, which is granted.

On motion duly made, seconded and carried, A.S. Johnson is appointed and directed to make settlement with the City Clerk, for license fees collected by him, for the year 1928, from January 1st, 1928, or dating from the date of the Audit for the year 1927.

J.F. Pauley appeared before the Common Council, and made request that the city take immediate steps to repair the sewer and remedy the conditions caused by same, leading from Stratton Hollow, under and through his property, on Hibbard Street, and Councilman, J.S. Cline moved that the request of Mr. J.F. Pauley be referred to the Street Committee, and that they together with the City Engineer and City Attorney investigate the conditions and report on same to the Council, not later than the 19th day of July, 1928, and said motion being duly seconded, carried.

An ordinance entitled "AN ORDINANCE DEDUCTING CERTAIN AMOUNT FROM SALARY OF CITY ASSESSOR FOR FAILURE TO ASSESS EACH AND EVERY TAX PAYER OF CITY OF PIKEVILLE, KENTUCKY." is presented and read to the Common Council, and J.S. Cline moved the adoption of same by the Common Council, and Richard Thompson seconded said motion, and upon a roll call the vote was as follows:

The City Clerk makes report as follows, on the Street Cleaning Contract, advertised for bids, pursuant to orders of this Council:

I have duly advertised for bids to be opened at the present meeting by persons proposing to enter into contract for cleaning the streets, alleys and public ways of the City of Pikeville, Ky., which advertisement was by public notice in conspicuous places about the said city of Pikeville, Ky., and that I have received the following bids, to-wit:

It appearing upon the opening of said bids received by the City Clerk, that Millard Burke had made the lowest and best bid, and Councilman, E.E. Trivette moved that the bid of Millard Burke, of \$200.00 per month be accepted by the City Council, and that contract be prepared in conformity with the Specifications and Ordinances covering the Street Cleaning work, and entered into with Mr. Millard Burke by the Mayor, for and on behalf of the City of Pikeville, Ky., and upon said motion being duly seconded, the vote was as follows:

The result of the vote being announced by the clerk, the mayor thereupon declared said motion carried.

Councilman, J.S. Cline moved that the Chief of Police and the two Policemen, be directed and ordered to examine all Catch Basins in the corporate limits of the City of Pikeville, Kentucky, every two weeks, and report the conditions of same to the City Attorney, and said motion being duly seconded, carried by a unanimous vote.

Councilman, J.S. Cline, moved that the matter of buying new fire hose be referred to the street Committee, together with the City Attorney, and said motion being duly seconded, carried.

On motion made seconded and carried, it is ordered that the Pike Ice Company be exonerated in the sum of \$240.00, on city taxes charged against them for the year 1925, by the City of Pikeville, Kentucky, divided as follows: On the General Fund \$150.00 and on the Water Levy \$90.00. Being taxes on a valuation of \$20,000.00, which is exempt for city purposes.

On motion made seconded and carried, it is ordered that the Pike Ice Company be exonerated in the sum of \$233.20, on city taxes charged against them for the year 1926, by the City of Pikeville, Kentucky, divided as follows: On the General Fund \$150.00, and on the Water Levy \$70.00, being taxes on a valuation of \$20,000.00, which is exempt for city purposes, plus a penalty of \$13.20, added for non-payment.

On motion made seconded and carried, it is ordered that the Pikeville Supply & Planing Mill Company be exonerated in the sum of \$240.00 on city taxes charged against them for the year 1925, by the city of Pikeville, Kentucky, divided as follows: On the General Fund \$150.00, and on the Water Levy \$90.00, being taxes on a valuation of \$20,000.00, which is exempt for city purposes.

On motion made seconded and carried, it is ordered that the Pikeville Supply & Planing Mill Company be exonerated in the sum of \$165.00, on city taxes charged against them for the year 1926, by the City of Pikeville, Kentucky, divided as follows: On the General Fund \$112.50, and on the water levy \$52.50, being taxes on a valuation of \$15,000.00, which is exempt for city purposes.

J.S. Cline moved that the Common Council refuse to take any action on the request for permit by the Pikeville Supply & Planing Mill Company, to install a gasoline tank on their property in the upper end of the city, nor take any action on the protest against the installation of said gasoline tank, filed by W.B. Call, and leave the parties as they were, and said motion being duly seconded, carried.

ORDERED THAT:

Mose Keen be allowed the sum of Twenty One (\$21.00) Dollars, for labor on streets, cleaning up after washouts, payable out of the Street Cleaning Budget fund.

ORDERED THAT:

The Southern Bell Telephone & Telegraph Company be allowed the sum of 65¢ cents for telephone calls from Police Station, as per bill rendered.
