At a regular adjourned meeting of the Common Council of the City of Pikeville, Kentucky, convened and held on the 7th day of November 1928, at the City Hall in said city, the following were present: Mayor, Geo. Pinson Jr., Councilmen I.E. Brooks, J.S. Cline, Oscar Jackson, Rush Sword and E.E. Trivette.

An ordinance entitled " AN ORDINANCE entitled an Ordinance setting aside \$5775.00 as a sinking fund to pay water works bonds and interest due January 1, 1929, and transferring that amount from the general water works fund to the sinking fund; and appropriating and transferring \$9000.00 from surplus now in general water works fund collected as water rents to city general fund to pay off and discharge outstanding warrants now in the hands of various parties, bearing legal interest." is presented and read to the council and J.S. Cline moved the adoption of same, and said motion being duly seconded by E.E. Trivette, upon a roll call of the council the vote was as follows:

The result of the vote being announced the mayor declared said motion lost.

On motion made duly seconded and carried, the Pikeville College is granted a permit to tap sewer on Kentucky Avenue and is permitted to go under High Street in order to do same, they agreeing that all damage that is done will be made good by them, in tapping said sewer.

Councilman, J.S. Cline moved that Richard Thompson, and the Supt. of the Water Works, be directed to go and repair the break-down in the sewer near the residence of Ferrell Pauley, at a cost not exceeding \$350.00, to be paid for by the city, and if it be found that the break-down was caused by the property owners in that section dumping dirt on the sewer, that the city attorney be directed to institute suit to recover the cost of the repairing from the owners of the property and that they be instructed to repair the sewer from the end of the street paving at Myra Barnes Avenue to the mouth of Hood Hollow, and I.E. Brooks, seconded said motion, which carried.
