## MINUTES } CITY OF PIKEVILLE

At a regular meeting of the Common Council of the city of Pikeville, Kentucky, convened and held at the city hall in said city on the 20th day of November 1928, the following were present: Mayor, Geo. Pinson Jr., Councilmen, I.E. Brooks, Oscar Jackson and Richard Thompson.

G.H. Francisco presented certificate of election as Councilman of the City of Pikeville, to fill out the unexpired term of B.A. Ratliff, which was filed and took the oath of office as required by law and entered upon his duties as councilman of the city of Pikeville, Kentucky.

Mrs. R.A. Johnson appeared before the Council and ask for an appropriation of One Hundred and Fifty (\$150.00) Dollars per year, in the interest of a city library.

The Mayor appointed as a Library Committee, I.E. Brooks, Rush Sword and City Attorney, John M. Hatcher, and directed them to meet with the committees of the civic organizations in the city on this matter of a city library and report their findings to this board at its next regular meeting.

On motion duly made, seconded and carried, it is ordered that W.B. Buskirk be exonerated from paying any of the city taxes charged against him for the year 1928, for the reason that said property was given in in the name of T.C. Buskirk for said year and paid on by him.

Councilman, G.H. Francisco, is appointed as a member of the Street Committee, to fill the vacancy created by the out-going councilman, J.S. Cline.

Councilman, G.H. Francisco moved that A.S. Johnson and W.T. Griffith, City Engineer be appointed and selected to work out and designate the kind of material to be used in the re-construction of the city streets that have been partly torn up by the Gas Company, and that they meet with the street committee partly torn up by a unanimous vote.

John M. Hatcher presented Insurance Policy #Al 1290913 of date November 12t 1928, covering public liability and property damage on the city fire truck, issued by the United States Fidelity & Guaranty Company to the City of Pikeville, Kentucky, and upon motion duly made, seconded and carried, said Policy is accepted and approved.

On motion duly made, seconded and carried, the City Attorney is directed to prepare and have ready for the consideration of the council at its next meeting, an Ordinance directing that all money belonging to the city shall be deposited on interest at not less than 4%.

Councilman, Richard Thompson, moved that the city attorney prepare an ordinance providing that the city borrow from the water fund the sum of Ten Thousand (\$10,000.00) Dollars, and issue their voucher for same bearing interest at 6%, and that said Ten Thousand be placed in the general expenditure fund of the city and be used for the purpose of discharging outstanding voucher indetedness of the city, and said motion being duly seconded by G.H. Francisco, carried by a unanimous vote

On motion duly made, seconded and carried the Mayor is directed to appoint a committee to confer with J.E. Stanley, Jailer of Pike County, and make contract as to the price of dieting and lodging city prisoners.

The Mayor, pursuant to the foregoing motion appointed on said committee, to confer with J.E. Stanley, Jailer, John M. Hatcher, City Attorney and Councilman, I.E. Brooks.

ORDERED THAT: J.M. Hatcher be allowed the sum of Eighty Two and 40/100 (\$82.40) Dollars, for premium on policy #AL 1290913 on Fire Truck of city, for year from Nov. 1st, 1928, to November 1st, 1929, payable out of Fire Department budget fund.

ORDERED THAT: Willard Thompson be allowed the sum of Two (\$2.00) Dollars, for hauling for city, and fixing approach on streets, payable out of Street Repair Budget fund.

On motion duly made, seconded and carried, council is adjourned until November 21st, 1928, at 7:00 o'clock.
