ORDERED THAT:

T.E. Newton be allowed the sum of \$49.15, as Current Expense Account of Supt. of water Dept. for month of March 1929, payable out of the Water Fund.

ORDERED THAT:

Foster Thornburg Hdwe. Co. be allowed the sum of One Hundred Eight (\$108.00) Dollars, for supplies to Water Dept. as per bill of 2-28-1929. Payable out of the Water Fund.

ORDERED THAT:

Banks-Miller Supply Company the sum of Twenty Seven and 14/100 (\$27.14) Dollars, for invoice of 3-5-29, payable out of the Water Fund.

ORDERED THAT:

Banks-Miller Supply Company the sum of Twenty Nine and 64/100 (\$29.64) Dollars, for invoice of 2-11-29, payable out of the water fund.

ORDERED THAT:

Pennsylvania Salt Manufacturing Company be allowed the sum of Fifty Eight and 50/100 (\$58.50) Dollars for invoice of March 2 1929, payable out of the Water Fund.

ORDERED THAT:

Cumberland Publishing Company be allowed the sum of Twenty Seven (\$27.00) Dollars, for invoice of March 25th 1929. Payable out of the Water Fund.

ORDERED THAT:

Welch Chemical Company be allowed the sum of Seventy Five (\$75.00) Dollars for Invoice of March 26th 1929, payable out of the water fund.

At a regular meeting of the Common Council convened and held at the City Hall in the City of Pikeville, Kentucky, on the 16th day of April 1929, the following were present: Geo. Pinson Jr., Mayor, Councilmen, G.H. Francisco, Oscar Jackson, Rush Sword and Richard Thompson.

On motion duly made, seconded and carried it is ordered that a building permit be granted to Jannie O. Heiser to construct and erect a building on Myra Barnes Avenue, same to be constructed in conformity with the City Ordinances regulating same.

Councilman, E.E. Trivette now present and acting:

On motion duly made, seconded and carried, it is ordered and directed that there be removed from their present location and placed on the street leading up to Peach Orchard Knob above the present pavement, one street light from in front of Ira Williams home on Huffman Avenue; One from on Scott Avenue in front of Sim Ledford's house or Cline Street; One from back of John Caudill's residence on Pike Avenue and one from in front of Joe Ramsey's residence on Scott Avenue, and that there be six new lights added to the number now in use by the city and placed on said street, making ten lights on said street above the present pavement and the Kentucky & West Virginia Power Company is directed to make said changes of the lights as herein set out and add the six additional lights and place them on said street.

Councilman, G.H. Francisco moved that the city Treasurer be directed to advertise for sale and receive bids on the Sewer Bonds voted by the city of Pikeville, Kentucky, at the regular November election 1923 and directed to be sold by Ordinance posted July 29th 1924, in the sum of \$11,000.00, bearing interest at 5½% due in thirty years from date, for the next thirty days, and said motion

On motion duly made, seconded and carried, it is ordered that W.P. Damron be exonerated from paying to the city of Pikeville, Poll tax charged against him for the year 1928, because of his physical condition.

ORDERED THAT:

Southeastern Kentucky Utilities Company be allowed the sum of Two Hundred (\$200.00) Dollars, for street repair work on 2nd and Caroline streets, payable out of the General Expenditure Fund.

ORDERED THAT:

Southern Bell Telephone & Telegraph Company be allowed the sum of One and 25/100 (\$1.25) Dollars, for service calls from Police Station, payable out of the General Expenditure Budget Fund.

ORDERED THAT:

Kentucky Wholesale Grocery Company be allowed the sum of Three and 25/100 \$3.25) Dollars for one keg of soda as per bill of 4-1-29, payable out of the Fire Department Budget Fund.

ORDERED THAT:

J.E. Stanley, Jailer, be allowed the sum of Four Hundred Fifty Eight and 30/100 (\$458.30) Dollars, for lodging and dieting City Prisoners up to December 31st 1928, payable out of the General Expenditure Fund.

On motion duly made, seconded and carried council is adjourned until the next regular meeting date, May 8th 1929.
