At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held on the 21st day of May 1929, the the city hall in said city the following were present: Mayor, Geo. Pinson Jr., Councilmen, Oscar Jackson, Richard Thompson, G.H. Francisco, E.E. Trivette and Rush Sword.

The resgination of Code Ramsey as Policeman in the place of T.M. Stratton who is on vaction is presented to the council and upon motion duly made seconded and carried said resignation is accepted.

It appearing that there is two vacancies in the Police Force of the City of Pikeville, Kentucky, by reason of the death of Lon Robinson and the resignation of Code Ramsey, Councilman, Rush Sword nominated K.B. Elswick to fill the office of Policeman, which vacancy was caused by the death of Lon Robinson and E.B. Coleman, to fill the vacancy in the office of Policeman caused by the resignation of Code Ramsey, and there being no further nominations, upon a roll call of the council the vote was as follows:

The result of the vote being announced the mayor declared said K.B. Elswick elected to the office of Policeman to fill the vacancy caused by the death of Lon Robinson and E.B. Coleman elected to the office of Policeman to fill the vacancy caused by the resignation of Code Ramsey.

K.B. Elswick and E.B. Coleman both being present in open council accepted the office of Policemen and took the oath of Office as required by law.

K.B. Elswick and E.B. Coleman presented Bond with the Fidelity & Casulaty Company of New York to the City of Pikeville, Kentucky in the sum of One Thousand (\$1,000.00) Dollars of date the 21st day of May 1929, as Policeman, which bonds by a unanimous vote of the council are approved and accepted.

On motion duly made seconded and carried it is ordered that a Committee be appointed to investigate and report to the Council, what it would cost the city to carry compensation Insurance on city employees.

The mayor, pursuant to the foregoing order appointed on said Committee John M. Hatcher, City Attorney and Councilmen, E.E. Trivette, Rush Sword and Oscar Jackson.
