

MINUTES } CITY OF PIKEVILLE

At a regular adjourned meeting of the Common Council of the City of Pikeville, Kentucky, convened and held on the 30th day of December 1929, at the City Hall in said city, the following were present: Mayor, Geo. Pinson Jr., Councilmen, G.H. Francisco, ~~Elmon~~ Elmon Walters and Stafford Sowards.

An Ordinance entitled "An Ordinance repealing an Ordinance prohibiting the storing of more than two motor vehicles within a frame structure within a closer distance than twelve feet of a building owned by another" is presented and read to the Council and Elmon Walters moved the adoption of said Ordinance and said motion being duly seconded by Stafford Sowards, upon a roll call the vote was as follows:

On motion duly made, seconded and carried, A.S. Johnson is employed to make an audit of the Water Works and City of Pikeville, Kentucky, records, for the year 1929, at a salary not exceeding \$150.00.

On motion duly made, seconded and carried, the Street Committee is directed to have repaired the Dixie Ratliff Alley, or make arrangements to have same repaired, and report their actions to this Board at its next regular meeting.

On motion of G.H. Francisco, duly seconded and carried, Council is adjourned until the next regular meeting date.

On motion duly made, seconded and carried, Mrs. Barbara Marrs is granted a permit to construct a brick building on Division Street, in the city, said building to conform to the Ordinances and Regulations adopted by the city.

On motion duly made, seconded and carried, J.C. Williamson is directed to repair the Street Sweeper, and put same in a workable condition.

Rush Sword moved that the Mayor be authorized to enter into a contract for an on behalf of the City of Pikeville, with the First National Bank of Pikeville, Kentucky, for the rental of a City Hall, and to approve said contract when accepted and approved by the City Attorney, and said motion being duly seconded, upon a roll call the vote was as follows:
