

MINUTES } CITY OF PIKEVILLE

At a regular meeting of the Common Council of the city of Pikeville, Kentucky, convened and held at the city hall in said city on the 4th day of April, 1930, the following were present: Councilmen, T.N. Huffman Jr., G.H. Francisco, D.C. Moore, Elmon Walters, Rush Sword and Stafford Sowards.

It appearing that F.A. Connolly, the Mayor of the city of Pikeville, is now absent from the city of Pikeville, Kentucky, and that such absence has continued for more than three successive days, thereupon, G.H. Francisco, nominated Councilman Rush Sword, as Mayor Protem, and said motion being duly seconded by Elmon Walters, carried by a unanimous vote.

Thereupon the said Rush Sword being present accepted the office of Mayor Protem, and took his seat as Mayor and the business of the council proceeded as follows:

On motion duly made, seconded and carried, the reading of the minutes of the council at its former meetings are dispensed with.

An Ordinance entitled "An Ordinance requiring all persons, firms and Corporations in the City of Pikeville, Kentucky, to place all garbage, trash, waste matter in proper receptacles, and stating how same shall be disposed of, and providing a penalty for violation thereof", is presented and read and upon motion duly made, seconded and carried, ~~council is adjourned~~ the further consideration of this Ordinance is passed until the next regular meeting date.
