

MINUTES } CITY OF PIKEVILLE

At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held at the City Hall in said city on the 3rd day of February 1931, the following were present: G.H. Francisco, Rush Sword, D.C. Moore and Elmon Walters, Councilmen and F.A. Connolly, Mayor.

The minutes of the last meeting of the council are read and approved.

It appearing that W.P. Call and J.M. York having paid street paving assessments against their property, direct to the contractors, Campbell-Johnson Company, in the total sum of \$1992.71; W.P. Call, in the sum of \$946.22, and J.M. York, in the sum of \$1046.55, for paving on Julius Avenue, and it further appearing that Bonds had been issued by the city, covering said amounts, which bonds are now held by Campbell-Johnson Company; Now Therefore, comes A.S. Johnson, Secretary and Treasurer of the Campbell-Johnson Company and surrenders to the City of Pikeville, in open council, bonds, numbers 21, 23, 24 and 26, Series "F", of denominations of \$500.00 each, of the total sum of Two Thousand (\$2000.00) Dollars, together with all coupons, except number one (1) of each bond, thereto attached, which bonds are ordered cancelled and turned over to the City Treasurer, to be preserved by him, until all of said bonds of said series have been surrendered, and upon motion duly made, seconded and carried, the lien on the property of J.M. York and W.P. Call for said Street Paving Assessments is released by the City of Pikeville, Kentucky.

The City clerk reports that pursuant to an order of this council that he advertised for bids on the construction of paving on Jefferson and Clevinger Streets, in the Pike County News for two consecutive weeks, and that he received the following bids:
