At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held at the city hall in the city of Pikeville, Kentucky, the following were present, Mayor, F.A. Connolly, Councilmen, Stafford Sowards, Rush Sword and G.H. Francisco.
