MINUTES } CITY OF PIKEVILLE

At a regular adjourned meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the City of Pikeville, Kentucky, on the 27th day of January, 1932, the following were present:

Mayor, F. A. Connolly, and Councilmen, R. G. Wells, Stafford Sowards, Mack Matney, T. E. Rogers and Uhlan Taylor. Councilman, C. D. Jacobs, was absent.

T. J. Robinson, Manager of Big Sandy Fruit Company, appeared before the Council and asked that the two city ordinances indexed under "K" in old ordinance book be enforced.

The Mayor referred to the Street and Sewer Committee, together with the City Attorney, the matter of repairing or constructing new sewer on south end of Jefferson Street.

The Mayor also referred to the same committee, together with the City Attorney, the matter of putting in surplus water sewer in alley intersecting with Elm Street, and said committee is directed to report to the Council its recommendations.

charles E. Hellier appeared in open Council and asked permission to replace bricks and repair street near his place of business on Huffman Street; and the Mayor referred said matter to the Street Committee, together with the City Engineer.

Hi Pauley, County Judge, appeared before the Council and asked for permission for Pike County to repair and reconstruct court-house.

Upon motion of R. G. Wells, duly seconded by Uhlan Taylor, and carried Pike County is granted permit to repair and reconstruct court-house in conformity with the laws, rules and ordinances of said City of Pikeville.

The Mayor referred to the Traffic Committee the matter of parking on Main Street during the building of the court-house, with direction to report to the Council its recommendations.

Various property owners and persons doing business on Second Street filed petition with the Council, stating that the paving on said Second Street was very unsatisfactory, and asking that said street be immediately fixed.

The Mayor referred said matter to the Street Committee with directions to report to the Council.

ORDERED THAT:

Stanley Motor Company be, and it is hereby allowed the sum of \$225.00 for one Ford Sedan automobile for city police department as per bill of Jan. 20, 1932, payable out of General Expenditure Fund.

It appearing that the City of Pikeville in order to meet the expense of the original street paving improvement on Jefferson and Clevenger Streets had bonds issued to secure the payment of same; and the abutting property owners on said streets having elected to pay for said improvement on the ten-year payment plan; and said bonds having been advertised as required by law, and the time for receiving bids for same having expired on January 26th, 1932, and the city clerk having received no bids therefor, Upon motion of R. G. Wells, duly seconded by T. E. Rogers, and

It is ordered and directed that said bonds in the sum of \$3692.65 be delivered to J. E. Stanley, Contractor, in full payment of balance due him for said improvement on said streets.

R. G. Wells moved that the salaries of all employees of the City Water Works Department be reduced ten percent, beginning and effective February 1, 1932. T. E. Rogers seconded said motion.

The result of the vote being announced the Mayor declared said motion carried.

R. G. Wells moved that B. W. Fortenbury be exonerated from the payment of taxes on the sum of \$400.00 for the year 1931: it appearing that said Fortenbury assessed two cars for \$1100.00, when as a matter of fact he did not own but \$700.00 worth of cars as of April 1, 1931, and that said \$400.00 was assessed through mistake by the assessor. T. E. Rogers seconded said motion, which carried.

Upon motion made, duly seconded and carried the city clerk is directed to write Southern Bell Telephone and Telegraph Company not to accept and charge any telephone calls, long distance or otherwise, including telegrams, to the City of Pikeville unless made by the Mayor, Chief of Police and three policemen.

Upon motion made, duly seconded and carried Council is adjourned until its next regular meeting. W. W. Atteller, APPROVED:
