ORDERED THAT: Home Furniture Company be, and it is hereby allowed the sum of \$17.70 for account in full to date, as per invoice of January 17, 1933, payable out of Fire Department Budget Fund.

ORDERED THAT: Irvine Lowe be, and he is hereby allowed the sum of \$1.98 for refund of 10% on 1932 tax ticket of \$19.88, payable out of General Expenditure Budget Fund.

The City Clerk presented and read letter to the Council from The Methodist Hospital of Kentucky, in which the Hospital asked to be exonerated from the payment of water rent for the period of one year, and the council passed said matter for further consideration.

Upon motion made, duly seconded and carried the city attorney is directed to write all persons who have not paid their street paving assessments on Jefferson Street, that unless same are paid on or before February 15th, 1933, suit will be instituted.

Upon motion of R. G. Wells, duly seconded by T. E. Rogers and carried, the city attorney is directed to institute suit for the closing of East end of Division Street in conformity with ordinance passed December 20th, 1932.

Upon motion made, duly seconded and carried Council is adjourned until its next regular meeting.

At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the City of Pikeville, Kentucky, on the 7th day of February, 1933, the following were present:

Mayor,	F. A. Connolly, and
Councilmen,	C. D. Jacobs; Uhlan Taylor;
	T. E. Rogers, Stafford Sowards,
	Mack Matney and R. G. Wells.

J. J. Moore, representing the Chesapeake and Ohio Railway Company, appeared before the City Council and asked that the Chesapeake and Ohio Railway Company be exonerated from the payment of 10% of its taxes for the year 1932, total amount being \$1572.88, 10% being \$157.28, for reason that said company had not been billed or notified of the discount of 10% allowed for payment before January 1, 1933, and hence it had no opportunity to pay same in time to receive the 10% discount.

T. E. Rogers moved that the Chesapeake and Ohio Railway Company be exonerated in the sum of 10% on \$1572.88, amount of city taxes due for the year 1932, as certified by the Auditor from Frankfort, Kentucky, said exoneration be made due to the fact of the late certification from the Auditor to the City Tax Collector, which notification was not received by the Chesapeake and Ohio Railway Company until date subsequent to the discount period, to-wit, January 6th, 1933. C. D. Jacobs seconded said motion. Upon roll call the vote was as follows:

The Mayor declared said motion carried and said Chesapeake and Ohio Railway Company be exonerated from the payment of \$157.28 on its 1932 city taxes.

The committee made report as to tax ticket of Robert Ratliff for the year 1932, said Robert Ratliff having heretofore asked that his ticket be lowered from valuation of \$18,500.00 to \$18,000.00, by reason of mistake of the Board of Supervisors for the year 1932, and after the introduction of proof and discussion, C.
