T. E. Rogers, chairman of committee, on Incinerator, reported to the Council that he and others had made trip to Williamson, W. Va., and inspected the incinerator at said city, and recommended that the city defer action on building of incinerator on account of large cost of operation of same, which report was accepted.

The Mayor appointed T. E. Rogers, R. G. Wells, C. D. Jacobs and Stafford Sowards as committee on Sewerage and Sanitation, and with request that they inspect suitable sites for dumping ground for city, and report to the Council their action.

The Mayor appointed R. G. Wells, C. D. Jacobs, T. E. Rogers and Stafford Sowards as committee to locate, inspect and view probable sites for city hall, with power to secure options on same, which committee will report to the Council its recommendations.

Upon motion made, duly seconded and carried the city attorney was directed to prepare parking ordinance for the consideration of the Council at its next meeting, to the effect that parking be changed on Second Street, and the ordinance heretofore passed regarding same, be changed to read as follows: "On the east side of Second Street between Huffman and Division Street, and on the west side from Division Street to Pike Avenue."

The City Treasurer filed financial statements of the city and water department as of February 7th, 1933.

Upon motion made, duly seconded and carried Council is adjourned until February 28th, 1933.

Upon motion of T. E. Rogers, duly seconded by Uhlan Taylor and carried, the mayor is directed to sign release to the Fidelity & Casualty Company of New York of the bond of Alex L. Ratliff, as police judge, said Ratliff having heretofore resigned, which the mayor did in open council.

T. E. Rogers introduced an ordinance entitled "AN ORDINANCE AMENDING AN ORDINANCE AND PROVIDING A PENALTY FOR VIOLATION THEREOF, PASSED AND APPROVED BY THE Council OF PIKEVILLE, KENTUCKY, AND THE MAYOR THEREOF ON THE 19th DAY OF APRIL, 1930", and moved that said ordinance be passed and adopted. R. G. Wells seconded said motion. Upon roll call the vote was as follows:
