ORDERED THAT:

J. M. Young, Jailer, be, and he is hereby allowed the sum of \$111.30 for keeping and dieting city prisoners during the month of March, 1933, payable out of Criminal Prosecution Budget Fund.

ORDERED THAT:

A. S. Ratliff be, and he is hereby allowed the sum of \$16.14 for 20% commission on tax sales of Viola (Mrs. H.M.) Hoskins, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Johnnie Williamson be, and he is hereby allowed the sum of \$7.00 for hauling trash &c from cemetery with truck during April, 1933, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Southern Bell Telephone and Telegraph Company be, and it is hereby allowed the sum of \$9.00 for toll service for city hall in full to March 16, 1933, payable out of General Expenditure Budget Fund.

Councilman, Uhlan Taylor, introduced an ordinance entitled "AN ORDINANCE REQUIRING ALL PERSONS, FIRMS OR CORPORATIONS ENGAGED IN THE TRANSPORTATION OF PERSONS FOR HIRE, AND NOT OPERATING UNDER A CERTIFICATE OF 'PUBLIC NECESSITY' IN THE CITY OF PIKEVILLE, KENTUCKY, TO MAINTAIN STATIONS: PROHIBITING THE SOLOCITING OF PASSENGERS FOR TRANSPORTATION, ON THE STREETS, ALLEYS, OR PUBLIC WAYS IN THE CITY OF PIKEVILLE, OTHER THAN AT THEIR STATIONS; AND PROVIDING A PENALTY FOR THE VIOLATION OF THIS ORDINANCE", and moved that said ordinance be passed, approved and adopted. Stafford Sowards seconded said motion. Upon roll call the vote was as follows:




The mayor declared said ordinance duly passed, approved and adopted.
