Arnold is now directed to pay money now held by it or him for purpose of paying said taxes to proper city officer.

Upon motion made, duly seconded and carried the city treasurer is directed to pay to Ab Bentley all monies now in his hands due said Bentley for side walk building, totaling about \$70.00.

Upon motion made, duly seconded and carried the city clerk is directed to issue vouchers drawn on water department to V. E.
