The City attorney appeared in open Council and advised the Council that if the franchise under which the Kentucky and West Virginia Power Company is now operating and furnishing power to the City of Pikeville expires on the 3rd day of February, 1935, as the city contends that it does, then a renewal franchise or contract must be advertised for sale not later than the 3rd day of August, 1933, the law of Kentucky requiring sale of such franchises to be advertised at least eighteen (18) months before the expiration of same. The City attorney further advised rhat the Council also should communicate with the proper authorities at Washington relative to the aid which the Federal Government is to furnish municipalities, to the extent of making outright gifts of thirty percent of the labor and material for any or all utilities.

After discussion of light franchise the mayor referred said matter to C. D. Jacobs and T. E. Rogers, who shall report to the council at its next regular meeting.
