At a regular adjourned meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the City of Pikeville, Kentucky, on the 10th day of August, 1933, the following were present:

ORDERED: THAT:

The Fabric Fire Hose Company be, and it is hereby allowed the sum of \$200.00 as credit on bill of \$600.00 for fire hose, as per invoice of July 15, 1933, payable out of Fire Department Budget Fund.

J. E. Sanders, representing Foster Thornburg Hardware Company, appeared before the council, and asked for permit for said company, to construct gasoline station and to tap and connect a private sewer line with the city sewer, on its property on corner of Huffman and College Streets in accordance with city ordinances and regulations; and upon motion made, duly seconded and carried said matter is passed until next meeting of council.


