J. E. Sanders, representing J. C. Wilson & Company, appeared before the council and asked that the city treasurer be directed to pay to J. C. Wilson & Company the sum of \$255.81, representing penalties now in hands of treasurer, paid to city by various parties owing street paving. The matter is passed for further consideration.

The Mayor appointed as committee to check up the J. C. Wilson & Company matter above referred to, city attorney, city clerk, city treasurer, J. E. Sanders and T. E. Rogers, which committee shall investigate said matter and report to the council its finding at next regular meeting.

It appearing that certain street paving bonds heretofore paid may be yet outstanding, the above committee is designated by the mayor to investigate same and report its findings to the council.

J. P. Hobson, Jr., attorney for Kentucky and West Virginia Power, R. E. Hodges, its local manager, and T. M. Watkins, one of its local officials, appeared in open council and the question of light franchise was discussed.

Councilman, Stafford Sowards, is now absent.

c. Dana May filed application for permit to erect an addition to his building on Main Street, which shall be in form of awning or porch extending over side walk, and which must have overhead support; and the mayor referred said matter to the city engineer, who shall investigate said matter and report his recommendation to the council at its next regular meeting.

The Kentucky and West Virginia Power Company, Inc., by its district manager and attorney, appeared before the council for the purpose of discussing the question of electric franchise in Pikeville. It developed that the city contends that the existing franchise expires February 15, 1935, and the power company contends the existing franchise expires in February, 1939. At the request of the power company the advertisement of the franchise ordinance adopted at the last meeting of the city council is postponed during the progress of said negotiations, estimated at a period of sixty days; and if it develops that the advertising of such would otherwise be material to the rights of the parties, the power company will not question the postponement of such advertisement, and advertising made beginning October 15, 1933, or prior thereto, is to have the same force and effect as if made beginning August 15, 1933.
