

MINUTES } CITY OF PIKEVILLE

At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the City of Pikeville, Kentucky, on the 3rd day of October, 1933, the following were present:

Mayor, F. A. Connolly, and
Councilmen, C. D. Jacobs,
R. G. Wells and
Uhlan Taylor.

Councilmen, Mack Matney, T. E. Rogers and Stafford Sowards were absent.

Mrs. Fanny Scott appeared before the council and placed a claim before it against the city in the sum of \$6.00 for alleged damage to automobile by reason of hole alleged to be in alley. The City recommended payment of same. The Mayor referred said matter to street committee with instructions to report to council its recommendation at the next regular meeting.

Stanley Greer appeared before the council and stated that he had paid to the city a fine in the sum of \$25.60 for violation of automobile laws, and asked that he be reimbursed by the city in said amount, for reasons given. R. G. Wells moved that said matter be laid over until the next meeting. Uhlan Taylor seconded said motion, which carried, and said matter is laid over for further investigation.

The city attorney asked that the salary of the street cleaner be increased in the sum of fifty cents per day, and that amount paid owner of team, wagon &c furnished for use of street cleaner be increased in the sum of fifty cents per day; and upon motion made, duly seconded and carried said matter is passed until the next regular meeting of the council.

It appearing that the city attorney instituted suit against various parties on Jefferson Street, and asked in said suit for principal, interest and penalties, for sewerage assessments due the city by said defendants, C. D. Jacobs moved that the penalties be remitted in case the defendants paid same without litigation. R. G. Wells seconded said motion. Upon roll call the vote was as follows:

The mayor declared said motion carried.

R. G. Wells stated that he formerly bought a piece of real estate in the City of Pikeville, Kentucky, from K. D. Keesee; that he built a house on said lot and afterwards ascertained that there was an old tax ticket against said property; that he looked up the tax schedule for said year and said Keesee had listed three pieces of property; that he is willing to pay \$20.00 on said tax ticket, being more than one-third of said ticket. Upon motion made, duly seconded and carried said matter was referred to the city attorney, who shall investigate said matter and report to the council his recommendation at its next regular meeting.

The City Attorney stated that there was litigation pending regarding various tax sales; that in some instances defendants were offering as defense that they had personal property which had not been levied on; and city attorney asked for permission to have said land sales set aside in event defendants' defense were sustained; and the council stated that the matter was in the hands of the city attorney and he should take such action as he saw fit.

C. D. Jacobs moved that V. E. Bevins, City Treasurer, issue check on City of Pikeville Water Works fund for the sum of \$850.00 for \$1000.00 worth of water works bonds, due 1954, 5%, being bond No. 128, which is now in said bank, and payable at said bank. Uhlan Taylor seconded said motion, which carried unanimously.

J. E. Sanders, attorney for James C. Willson & Company, presented bill of James C. Willson & Company in the sum of \$255.91 for penalties and interest on past due installments collected by the City of Pikeville on 1923 Series of Street Paving Bonds, owned by said company, said bill being itemized. R. G. Wells moved that the city treasurer, V. E. Bevins, be directed to draw check for payment of said \$255.91 out of penalties now in his hands and in said street paving fund referred to, in favor of said J. C. Willson & Company. Uhlan Taylor seconded said motion, which carried unanimously.

Letter from Kentucky and West Virginia Power Company, of date September 8, 1933, addressed to the mayor and councilmen was presented and read in executive session, but no action taken regarding same.

Upon motion made, duly seconded and carried said Stratton was allowed the sum of \$135.00. To the disallowance of the sum of \$15.00 said Stratton excepts, and accepts said \$135.00 as a credit only. Therefore

A. S. Ratliff, City Attorney, presented and filed bill for \$100.00 for salary as city attorney for the month of September, 1933. Upon motion made, duly seconded and carried said Ratliff was allowed the sum of \$90.00. To the disallowance of the sum of \$10.00 said Ratliff excepts, and accepts said \$90.00 as a credit only. Therefore,

ORDERED THAT:

A. S. Ratliff be, and he is hereby allowed the sum of \$90.00 for salary as city attorney for the month of September, 1933, payable out of Officers Salary Budget Fund.

J. M. Hatcher, City Clerk, filed and presented bill for \$87.00 for salary and services as city clerk for the month of September, 1933. Upon motion made, duly seconded and carried said Hatcher was allowed the sum of \$78.30. To the disallowance of the sum of \$8.70 said Hatcher excepts and accepts said \$78.30 as a credit only. ORDERED THAT:



ORDERED THAT:






