Clyde Childers offered and introduced an ordinance entitled "AN ORDINANCE PROVIDING FOR AND DIRECTING THE ADVERTISEMENT AND SALE OF A FRANCHISE FOR AN ELECTRIC POWER COMPANY TO OWN, MAINTAIN AND OPERATE ITS LINE UPON, ALONG, UNDER AND OVER THE STREETS, ALLEYS, SIDEWALKS AND PUBLIC WAYS OF THE CITY OF PIKEVILLE, KENTUCKY, AND REGULATING SAME"; and moved that same be passed and adopted as an amendment to or a substitute for resolution introduced by Mr. Syck entitled "A Resolution for the sale of a Franchise for electric light and power system".
