Robert Ratliff appeared before the council and question of charge by gas franchise holder for installation of gas mains from main line to curb and property line was discussed at length.

Mr. Woody of Woody's Meat Market appeared before the council and asked that it pass ordinance permitting parking in front of his place of business in James Hatcher Hotel Building for 30 minutes, and said matter was passed until next meeting.

Clyde L. Robinson appeared before the council and stated that the street was dirty and dusty in front of his property on Hibbard Street, and asked that the city oil said street, and said matter is referred to the Street Committee, which shall report to the council at its next regular meeting.

J. Lee Hatcher, City Assessor, appeared before the council and asked that the council appoint a deputy assessor for the year 1934, and recommended F. A. Goff.
