Clyde L. Robinson appeared before the council and stated that the street was dirty and dusty in front of his property on Hibbard Street, and asked that the city oil said street, and said matter is referred to the Street Committee, which shall report to the council at its next regular meeting.

J. Lee Hatcher, City Assessor, appeared before the council and asked that the council appoint a deputy assessor for the year 1934, and recommended F. A. Goff.

A. S. Johnson moved that F. A. Goff be appointed deputy assessor of the City of Pikeville for the year 1934 without expense or charge to the city. H. E. Syck seconded said motion, which carried unanimously.

H. E. Syck moved that Sidney Trivette, attorney, be directed to carry to Court of Appeals of Kentucky, appeal in the case of T. M. Stratton v. City of Pikeville. Clyde Childers seconded said motion. Upon roll call the vote was as follows:

G. C. Honaker appeared before the council and asked for permit to build shed back of the Dr. Walters Building on Second Street. H. E. Syck moved that said permit be granted subject to all provisions of fire zone ordinances, rules and regulations now in effect. A. S. Johnson seconded said motion, which carried.

ORDERED THAT:

A. S. Ratliff be, and he is hereby allowed the sum of \$40.47 for 20% commission on \$202.37 tax sales of Eleanor Brookes, paid to county court clerk, payable out of General Expenditure Budget Fund.

Clyde Childers moved that the mayor appoint a committee, which should act with the city treasurer, in investigating and ascertaining whether or not the city is in position to reduce water rates to inhabitants of the City of Pikeville, which committee shall report to the council at its next regular meeting. H. E. Syck seconded said motion, which carried.

The Mayor appointed on above committee the following: H. E. Syck, and Clyde Childers, together with the city treasurer.
