H. E. Syck moved that bid of Robert Williams, in which he agreed to furnish team and wagon for use of street cleaner in cleaning streets at price of \$1.95 per day, be accepted, effective April 18, 1934. A. S. Johnson seconded said motion, which carried unanimously.

H. E. Syck moved that Sidney Trivette, attorney, be directed to carry to Court of Appeals of Kentucky, appeal in the case of T. M. Stratton v. City of Pikeville. Clyde Childers seconded said motion. Upon roll call the vote was as follows:

Said ordinance received a majority of the votes and said motion therefore carried and said ordinance was duly passed and adopted.

The City Clerk presented and filed report, pursuant to resolution entitled "A Resolution directing the Clerk of the City Council to advertise the sale of an electric franchise", adopted by the council April 3, 1934, which is in words and figures as follows:

TO THE MAYOR AND CITY COUNCIL OF THE CITY OF PIKEVILLE, PIKE COUNTY, KENTUCKY:

I, the undersigned, John M. Hatcher, City Clerk for Pikeville, Kentucky, do hereby respectfully report to the mayor and city council that as directed in a resolution of the city council adopted at a meeting on March 19, 1934, and passed over the veto of the mayor on the 3rd day of April, 1934, and after duly advertising the same by notices published in three consecutive issues of The Pike County News, on the 5th day of April, the 12th day of April and the 19th day of April, 1934, and posted at five conspicuous places about the Town of Pikeville, Kentucky, I did on the 20th day of April, 1934, as directed in said resolution, and at the front door of the town hall in the City of Pikeville, Kentucky, offer for public sale a franchise for the use of the public streets for the distribution of light and power to the inhabitants and consumers of the City of Pikeville, as set out in said resolution above described.

Whereupon Kentucky & West Virginia Power Company, Inc., by R. E. Hodges as District Manager, presented a certificate from V. E. Bevins, City Treasurer of the City of Pikeville, evidencing the depositing with him of the sum of Two Thousand Five Hundred (\$2500.00) Dollars as a condition to his bidding at said sale; and thereupon said Kentucky & West Virginia Power Company, Inc., by said Hodges and Sidney Trivette proceeded to bid at said sale. Said Sidney Trivette bid the sum of Four Thousand Seven Hundred (\$4700.00) Dollars. He was declared by the clerk to be the highest bidder. He was asked for payment of said sum of money, but stated he had sixty days in which to pay same, and he has not paid or tendered same todate. Kentucky & West Virginia Power Company by R. E. Hodges, bid the sum of Four Thousand Six Hundred (\$4600.00) Dollars. Kentucky & West Virginia Power Company, Inc., by R. E. Hodges, tendered the amount of its bid, to-wit: The sum of Four Thousand Six Hundred (\$4600.00) Dollars in cash; and at the request of the undersigned delivered to the undersigned in lieu of such cash a cashier's check by the proper officer of the Pikeville National Bank, Pikeville, Kentucky, for said sum of Four Thousand Six Hundred (\$4600.00) Dollars; and said Power Company also reduced its bid to writing and delivered same to the undersigned.

There is attached hereto and made part of this report a copy of notice of said sale, the written bid of said Kentucky & West Virginia Power Company, the certificate of the City Treasurer above referred to, and the cashier's check for Four Thousand Six Hundred (\$4600.00) Dollars, the amount bid by said Kentucky & West Virginia Power Company, Inc.

A. S. Johnson moved that the two bids received for lighting streets of the City of Pikeville be opened and read by the city clerk. H. E. Syck seconded said motion, which carried.

The city clerk opened the bid of Sidney Trivette and read same to the council, which is in words and figures as follows:

"TO THE MEMBERS OF THE CITY COUNCIL AND THE MAYOR:
I submit for your consideration the following rates for the
lighting of the streets and alleys according to the provisions as
set out in the ordinance directing this sale:
For each 60 candle power lamp, \$15.00 per year
For each 100 candle power lamp, 21.00 " "
This bid is accompanied by the certified check of \$50.00.

The undersigned, Kentucky & West Virginia Power Company, Inc., a corporation duly organized and existing under the laws of the State of Kentucky, hereby offers to your honorable body to enter into a contract with the City of Pikeville, Pike County, Kentucky, for the lighting of said city in accordance with a resolution of your council dated the 19th day of March, 1934; and to furnish illumination for not less than nine (9) 100 candle power lamps at the rate of Twenty-Four (\$24.00) Dollars per year for each one hundred candle power lamp; for not less than one hundred sixty-eight (168) 60 candle power lamps at the rate of Eighteen (\$18.00) Dollars per year for each sixty candle power lamp; all for a period of five (5) years, with the right of renewal to the city as set forth in said resolution.

said contract is to be drawn in writing and signed by the respective parties thereto, and to contain the provisions specified by said resolution above referred to.

The city attorney presented and asked the council to spread at large on its order book an order relating to light franchise, but the council took no action on same and it was marked "Tendered".

The City Attorney advised the council that the sale of a franchise cannot be advertised by resolution, but must be done by ordinance.

A. S. Johnson called up ordinance entitled "AN ORDINANCE granting the right, privilege, franchise and authority to construct, maintain and operate in, above, under, across and along the streets, thoroughfares, alleys, bridges and public places of the City of Pikeville lines for the distribution of electric energy" and moved that said ordinance be passed and adopted. Arthur Fields seconded said motion. Upon roll call the vote was as follows:

A. S. Johnson moved that W. M. Auxier be appointed deputy assessor of the City of Pikeville for the year 1934 without expense or charge to the city, and that the order heretofore made appointing F. A. Goff deputy assessor be set aside. H. E. Syck seconded said motion, which carried.

Upon motion made, duly seconded and carried J. D. Sword was employed to remodel A. D. Cline building on Division Street for the city, at the price of forty cents per hour, with agreement that fifty percent of all wages earned in this work be applied to his delinquent water and tax accounts.

Clyde Childers moved that K. L. Arnold be appointed to make settlement with T. M. Stratton on all replevin bonds and fines from the beginning of his term as chief of police to date. A. S. Johnson seconded said motion, which carried.

Upon motion made, duly seconded and carried council is adjourned until its next regular meeting.
