MINUTES | CITY OF PIKEVILLE

The City Attorney advised the council that the sale of a franchise cannot be advertised by resolution, but must be done by ordinance.

A. S. Johnson called up ordinance entitled "AN ORDINANCE granting the right, privilege, franchise and authority to construct, maintain and operate in, above, under, across and along the streets, thoroughfares, alleys, bridges and public places of the City of Pikeville lines for the distribution of electric energy" and moved that said ordinance be passed and adopted. Arthur Fields seconded said motion. Upon roll call the vote was as follows:

A. S. Johnson moved that W. M. Auxier be appointed deputy assessor of the City of Pikeville for the year 1934 without expense or charge to the city, and that the order heretofore made appointing F. A. Goff deputy assessor be set aside. H. E. Syck seconded said motion, which carried.

Upon motion made, duly seconded and carried J. D. Sword was employed to remodel A. D. Cline building on Division Street for the city, at the price of forty cents per hour, with agreement that fifty percent of all wages earned in this work be applied to his delinquent water and tax accounts.

Clyde Childers moved that K. L. Arnold be appointed to make settlement with T. M. Stratton on all replevin bonds and fines from the beginning of his term as chief of police to date. A. S. Johnson seconded said motion, which carried.

Upon motion made, duly seconded and carried council is adjourned until its next regular meeting.
