Rush Sword seconded said motion. Upon roll call the vote was as follows:

Contract between Tom Wolford and the City of Pikeville was presented, whereby said Wolford agreed to furnish the City a dumping ground at or near the head of Ferguson Creek at rental of \$30.00 per year, beginning May 1, 1934. Upon motion made, duly seconded and approved the mayor was directed to sign said contract in behalf of the city and the clerk was directed to issue voucher on city for said amount.

Upon motion made, duly seconded and carried it is ordered that the judgment in case of J. Lee Hatcher vs. City of Pikeville, including the cost, be paid in full, and the city clerk is directed to draw city warrants for said amount.

ORDERED THAT:

J. Lee Hatcher be, and he is hereby allowed the sum of \$50.00 for two years back salary as per judgment of the Pike Quarterly Court and Pike Circuit Court, payable out of General Expenditure Budget Fund.

ORDERED THAT:

G. C. Rowe be, and he is hereby allowed the sum of \$28.05 for cost and interest on judgment in case of J. Iee Hatcher vs. City of Pikeville, payable out of General Expenditure Budget Fund.

ORDERED THAT:

American Railway Express Company be, and it is hereby allowed the sum of \$4.19 for express on rim for wheel of street sweeper, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Ed Auxier be, and he is hereby allowed the sum of \$1.50 for six hours labor washing streets & 25¢ per hour, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Ed Auxier be, and he is hereby allowed the sum of \$18.00 for six days labor & 3.00 per day, during Clean-up week, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Curtis Vanover be, and he is hereby allowed the sum of \$1.50 for six hours labor washing streets, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Curtis Vanover be, and he is hereby allowed the sum of \$14.40 for six days work during Clean-up week, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Ballard Edmunds be, and he is hereby allowed the sum of \$14.00 for four days work during Clean-up week, @ \$3.50 per day, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Marion Hall be, and he is hereby allowed the sum of \$14.40 for six days work during Clean-up week, @ \$2.40 per day, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Ballard Morris be, and he is hereby allowed the sum of \$3.00 for serving one day as special policeman during the month of May, 1934, payable out of General Expenditure Budget Fund.

ORDERED THAT:

J. D. Sword be, and he is hereby allowed the sum of \$21.30 for one-half amount allowed for 106% hours work, @ 40% per hour, on new city hall on Division Street, other one-half being paid to water superintendent on water bill of J. D. Sword, payable out of General Expenditure Budget Fund.

ORDERED THAT:

T. E. Newton, Water Superintendent, be, and he is hereby allowed the sum of \$21.30 for payment on water bill of J. D. Sword, deducted from bill allowed Sword for work on city hall, payable out of General Expenditure Budget Fund.

ORDERED THAT:

D. R. Holley be, and he is hereby allowed the sum of \$6.00 for two days work as special policeman, May 15-16-1934, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Herbert Adkins be, and he is hereby allowed the sum of \$7.00 for two days work during Clean-up week, May 7-12, 1934, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Dave Roberts be, and he is hereby allowed the sum of \$3.00 for 12 hours work washing streets, May 12-13, 1934, payable out of General Expenditure Budget Fund.

Upon motion made, duly seconded and carried council is adjourned until May 17th, 1934.
