At a regular adjourned meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the City hall in the City of Pikeville, Kentucky, on the 17th day of May, 1934, the following were present:

Councilmen, Arthur Fields and G. C. Call, were absent.

Councilman, Rush Sword, introduced an ordinance entitled "AN ORDINANCE regulating the parking of busses on the west side of Main Street between the corner of Main and Division streets and the alley between the property of J. D. Caudill and T. G. Parker; and fixing the penalty for any violation of this ordinance, in Pikeville, Kentucky", and moved that said ordinance be passed and adopted. A. S. Johnson seconded said motion. Upon roll call the vote was as follows:

The mayor declared said motion carried and said ordinance duly passed and adopted.

The contract between Tom Wolford and City of Fikeville, whereby said Wolford agreed to furnish dumping ground for City of Pikeville for one year beginning May 1, 1934, at rental of \$30.00 per year was presented. Upon motion made, duly seconded and carried the mayor was authorized and directed to execute said contract in behalf of the city.

ORDERED THAT:

Buff (Tom) Wolford be, and he is hereby allowed the sum of \$30.00 for rental for garbage dump on Ratliffs Creek for one year from May 6, 1934, payable out of General Expenditure Budget Fund.

A. S. Johnson moved that the order heretofore made allowing judgment and cost in case of J. Lee Hatcher vs. City of Pikeville be rescinded, and that vouchers No. 1546, payable to J. Lee Hatcher in the sum of \$50.00, and No. 1548 payable to G. C. Rowe, S. P. C., in the sum of \$28.05, be returned, canceled, marked "void" and held for naught. H. E. Syck seconded said motion, which carried unanimously.

ORDERED THAT:

Junior Burke be, and he is hereby allowed the sum of \$1.50 for delivering posters for Clean-up week of May 7-12, 1934, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Don Ramsey be, and he is hereby allowed the sum of \$6.00 for two days work as special policeman, May 15-16, 1934, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Bob Hopkins be, and he is hereby allowed the sum of \$6.00 for two days work as special policeman, May 15-16, 1934, payable out of General Expenditure Budget Fund.

ORDERED THAT:

James McGuire be, and he is hereby allowed the sum of \$26.18 for amount allowed for 1062 hours at 30% per hour for work on new city hall on Division Street, less \$4.77 paid A. J. Jackson, Tax Collector, for city taxes, total allowed \$31.95, payable out of General Expenditure Budget Fund.

ORDERED THAT:

A. J. Jackson, Tax Collector, be, and he is hereby allowed the sum of \$4.77 for city taxes of James McGuire for years 1931, 1932 and 1933, deducted from bill allowed McGuire for work done for city, payable out of General Expenditure Budget Fund.

Mrs. J. W. Langley and Robert Elliott appeared before the council and asked that their water bills be reduced, and said matter was referred to the Water Committee.

Clyde Childers introduced an ordinance entirled "AN ORDINANCE providing for the widening of Cline Street, and declaring the widening of said street a necessity, and providing for the acquiring of necessary rights of way andland", and moved that said ordinance be passed and adopted. A. S. Johnson seconded said motion. Upon roll call the vote was as follows:

H. E. Syck moved that the city take such steps as are necessary to reduce all service charges from \$1.00 per month to 50¢ per month to all water users living outside of the corporation of the City of Pikeville. Clyde Childers seconded said motion, which carried.

Upon motion made, duly seconded and carried council is adjourned until its next regular meeting.

M., at the city hall, for the purpose of making or approving contract between the City of Pikeville and the State Highway Commission for the improvement of Cline Street, in said city, and also for the purpose of passing a resolution with respect to said Cline Street improvement.

Arthur Fields introduced and moved that the following order be entered, which is in words and figures as follows:

> "ORDERED that Honorable K. J. Day, Mayor of the City of Pikeville, Kentucky, acting for and on behalf of the said city, be, and he is hereby authorized to enter into in behalf of said city, such contract, or contracts, that may be necessary between the said city and the State Highway Commission of Kentucky, whereby and wherein the City of Pikeville may, or shall, bind itself to maintain Cline Street, which it is proposed be widened with funds provided and apportioned to the State of Kentucky under Section 204 of the National Recovery Act, and said maintenance by the city be done according to such rules and regulations as the State Highway Commission of Kentucky may from time to time make and promulgate.
