H. E. Syck moved that the city take such steps as are necessary to reduce all service charges from \$1.00 per month to 50¢ per month to all water users living outside of the corporation of the City of Pikeville. Clyde Childers seconded said motion, which carried.

Upon motion made, duly seconded and carried council is adjourned until its next regular meeting.

At a special or call meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the city of Pikeville, Kentucky, on the 2nd day of June, 1934, the following were present:

You and each of you will take notice that there will be a meeting of the Council of the City of Pikeville, Ky., this evening at 8 o'clock P. M., at the city hall, for the purpose of making or approving contract between the City of Pikeville and the State Highway Commission for the improvement of Cline Street, in said city, and also for the purpose of passing a resolution with respect to said Cline Street improvement.

Arthur Fields introduced and moved that the following order be entered, which is in words and figures as follows:

"ORDERED that Honorable K. J. Day, Mayor of the City of Pikeville, Kentucky, acting for and on behalf of the said city, be, and he is hereby authorized to enter into in behalf of said city, such contract, or contracts, that may be necessary between the said city and the State Highway Commission of Kentucky, whereby and wherein the City of Pikeville may, or shall, bind itself to maintain Cline Street, which it is proposed be widened with funds provided and apportioned to the State of Kentucky under Section 204 of the National Recovery Act, and said maintenance by the city be done according to such rules and regulations as the State Highway Commission of Kentucky may from time to time make and promulgate.

This contract is entered into by the City of Pikeville, Kentucky, under and by virtue of authority vested in it as a municipal corporation of the fourth class by Section 3562, Carroll's Kentucky Statutes, Edition 1930, and which said section is a part of the charter of fourth-class towns."

Clyde Childers seconded Mr. Fields' motion, which carried unanimously.

Clyde Childers introduced and moved the adoption of the following resolution, which is in words and figures as follows:

"WHEREAS, the State Highway Commission will submit a project for the improvement of the following:

The City of Pikeville on Cline Street from end of bridge over Levisa fork of Big Sandy River to intersection with Central Avenue, length of project approximately 2335 feet; and will recommend its approval by the Secretary of Agriculture for construction with funds apportioned to the State under section 204 of the National Industrial Recovery Act, subject, however, to the condition that the City of Pikeville shall provide for its proper maintenance after completion of its improvement; and subject also to the agreement that the City of Pikeville will enter into an agreement with the State Highway Commission to permit parking only on one side of the street;

NOW, THEREFORE, the said City of Pikeville hereby requests the Highway Department to submit the aforementioned project with recommendation that it be approved by the Secretary of Agriculture, and agrees that if such project is approved and constructed by the State Highway Department, it thereafter, at its own cost and expense, will maintain the project in a manner satisfactory to it or its authorized representatives, and will make ample provision each year for such maintenance, and further agrees that it will enter into an agreement with the State Highway Commission to permit parking only on one side of the street."

Arthur Fields seconded Mr. Childers' motion. Upon roll call the vote was as follows:

Clyde Childers introduced and moved that the following order be entered:

"ORDERED that the contract entered into the 2nd day of June 1934, between the City of Pikeville, Kentucky, and the State Highway Commission of Kentucky, for maintaining Cline Street, be, and the same is hereby ratified and approved by the Council of the City of Pikeville, Kentucky.

Five copies of the contract, referred to herein, having been executed, it is ordered and directed that one copy of contract be retained by the city and four copies be transmitted to the State Highway Commission of Kentucky."

Arthur Fields seconded Mr. Childers' motion, which carried unanimously.

Upon motion made, duly seconded and carried council is adjourned until its next regular meeting.
