

## MINUTES } CITY OF PIKEVILLE

At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the City of Pikeville, Kentucky, on the 19th day of June, 1934, the following were present:

Councilmen, H. E. Syck,  
Clyde Childers,  
Rush Sword,  
G. C. Call and  
A. S. Johnson.

Mayor, K. J. Day, and Councilman, Arthur Fields, were absent.

Upon motion made, duly seconded and carried H. E. Syck was elected mayor protem and assumed the duties as such.

Landon Honaker appeared before the Council and stated that the Big Hollow Coal Company had placed steel and other material on railroad property near his residence on Railroad Street and asked that same be removed, and the city clerk was directed to write the C. & O. Railroad Company with reference to same.

A. J. Akers appeared in open council and stated that people were parking cars on side walks and parkways on Main and Pike Streets, and asked that same be stopped, and that an ordinance be passed prohibiting same, and the matter is passed until the next meeting of the council.

Agreement was presented and filed, signed by Vernon Sanders, Captain of the National Guard in which he agreed to not rent Armory building for dances during the term of the present council.

Upon motion made, duly seconded and carried Okey Hayslip was employed to audit sinking funds of water works, settle with chief of police and city clerk's licenses.

Clyde Childers moved that O. S. Batten be employed to draw plans for the erection of city fire station and city jail, provided satisfactory price can be arrived at between said Batten and the city. Rush Sword seconded said motion, which carried.

Upon motion made, duly seconded and carried the city attorney is directed to prepare ordinance placing tax or license of \$10.00 on first gasoline pump and \$5.00 on each additional pump.

Upon motion made, duly seconded and carried it is ordered that the city attorney and other attorney or attorneys representing the city be authorized and directed to prosecute to the Pike Circuit Court and Court of Appeals of Kentucky the condemnation suits now pending in the Pike County Court of the City against various parties for the widening of Cline Street.

Upon motion made, duly seconded and carried the city clerk is directed to make tax tickets against the Curnutt Heirs property located on Cline Street and other streets in the City of Pikeville for the years 1929, 1932 and 1933, on valuation of \$6000.00 per year, and certify same to the Tax Collector.

Upon motion made, duly seconded and carried the city clerk was directed to have inserted in the Pike County News, the following notice:

"NOTICE TO PERSONS PARKING MOTOR VEHICLES OVER NIGHT:

It appearing that the street cleaner cannot clean streets at night, for reason that people are parking their cars on streets and side walks in violation of city ordinances,

All automobile owners and the public are hereby notified that beginning Monday, June 25, 1934, all parking ordinances relating to parking on streets, side walks, alleys and park ways, after twelve o'clock, midnight, will be strictly enforced, and violators thereof will be fined as set out in said ordinances.

which said notice was given to the paper under date June 20, 1934.

Upon motion made, duly seconded and carried the city clerk was directed to bill Sam M. Caudill for \$37.50 for rent of city hall building for month of May, 1934, and Elliott Huffman for \$30.00 for rent of building on Division Street for months of April and May, 1934, which the city clerk did.

ORDERED THAT:

James McGuire be, and he is hereby allowed the sum of \$9.00 for 30 hours work on new city hall during June, 1934, payable out of General Expenditure Budget Fund.

ORDERED THAT:

J. D. Sword be, and he is hereby allowed the sum of \$21.40 for 107 hours work on new city hall during June, 1934, @ 40¢ per hour, total \$42.80, remaining one-half being paid to water department and tax collector on said Sword's bills, payable out of General Expenditure Budget Fund.

## ORDERED THAT:

O. S. Batten be, and he is hereby allowed the sum of \$20.00 for engineering work, May 26 and 27th, 1934, on proposed widening of Cline Street, payable out of General Expenditure Budget Fund.

A. J. Jackson be, and he is hereby allowed the sum of \$28.00 for balance allowed Ballard Morris for painting city hall and paid to said Jackson by order of said Morris, payable out of General Expenditure Budget Fund.

## ORDERED THAT:

A. J. Jackson, Tax Collector be, and he is hereby allowed the sum of \$14.31 for amount deducted from bill allowed J. D. Sword, for work on city hall, June 19, 1934, to be applied on said Sword's taxes, payable out of General Expenditure Budget Fund.

## ORDERED THAT:

T. E. Newton, water superintendent, be, and he is hereby allowed the sum of \$7.09 for amount deducted from bill allowed J. D. Sword, June 19, 1934, for work on city hall, to be applied on said Sword's water rent, payable out of General Expenditure Budget Fund.



Upon motion made, duly seconded and carried the city attorney is directed to prepare ordinance prohibiting doors and gates opening out on side walks in the city, and present same for consideration of council at its next meeting.



John A. Bentley appeared before the Council and stated that he owned a house and lot on Poplar or Willow Street, running off of Kentucky Avenue; that no water mains have ever been extended to said house, and he asked that water mains be extended to said property; and said matter was referred to the Water Committee, which will report to the Council at its next regular meeting.

James W. Childers appeared in open council and stated there was a fire hazard next door to his property on North Hellier Street, and that said building was maintained in an unsanitary manner; and he is referred to the Board of Health for consideration of said matter.

## ORDERED THAT:

James W. Childers be, and he is hereby allowed the sum of \$1.50 for refund on 1932 poll tax, same having been paid by said Childers, but not allowed to vote, payable out of General Expenditure Budget Fund.

## ORDERED THAT:

J. M. Hatcher be, and he is hereby allowed the sum of \$60.00 for advancement on salary and services as city clerk for the month of June, 1934, payable out of Officers' Salary Budget Fund. as of June 18, 1934.
